The EducAid India Charitable Trust of 30 Fallows Road, Northleach, Cheltenham, Gloucestershire GL54 3QQ was constituted by a Deed of Trust dated 1<sup>st</sup> July 2009, and amended by Deeds of Trust dated 20<sup>th</sup> October 2010 to meet Charity Commission requirements. The charity's bankers are the Cirencester Branch of HSBC plc.

The principal object of the charity is to provide for the funding of projects in support of all aspects of caring for the education of children in India.

The Trustees do not receive any remuneration for their work, although Field Trip expenses can be reimbursed. However, specific donations are received to cover all administrative expenses, including bank and other charges, Field Trips and any other work required to monitor the use of the funding provided by EducAid India. The charity does not employ any staff and has no office premises.

The Trustees have considered the risks that the charity may be running, whether arising from future inability to meet commitments they have made or from misappropriation. They consider that the risks are minimal.


The trust deed gives the Trustees wide powers of investment.

The net change in the funds over the year was an increase of £2,259.97 to £13,902.89. This increase was the result of £25,313.58 income generated for charitable purposes, of which £22,717.61 was distributed for those purposes. Administration and other expenses were £336.00.

Accounting Basis - The accounts have been prepared on an accrual basis.

- Towards Future: £2,584.21 to fund 2 teachers at the Sishumon Learning Centre in Kalikapur Village;

As the trustees of the charity you are responsible for the presentation of the charities accounts in accordance with the requirements of the Charities Act 2011 ('the Act').


