Activities: Village Foundations is currently working in Mwanyama Village, Nkhudzi Bay, Malawi. It is in the process of setting up a health post with a view to developing into a fully blown clinic for under 5's and their mothers. The Charity is currently offering support/services in pneumonia, HIV & Malaria Treatment, ante/post natal checks, family planning support and education & cervical cancer screening.

Accounts

Overview of VFs activities throughout 2024

UK based activities

1. Two new Trustees joined the UK Board of Trustees; Benjamin Bell, a Paramedic & Vera Hau, born and raised in Malawi, but now working in the UK as an International Recruitment Officer for Nottingham Trent University
2. A new website was developed to promote the corporate identity of the charity, re-establishing the brand and to support Communications and maximise opportunities for funding
3. Successfully procured, developed, and implemented a new production suite for VF which will facilitate efficient ways of working and administration for the teams based in the UK and Malawi as well as supporting effective communication between the teams
4. Successful fundraising drives including the securing of a new donor willing to support the funds required for the Mwanyama Clinic upgrade to a Dispensary
5. Development of an International Volunteer Programme piloted with two healthcare workers:
Ben Bell, now a Trustee, who used his experience as a Paramedic to offer advice and guidance as well as healthcare interventions during his placement.
Rosalind Rashid, a Medical Student, who worked alongside Clinic staff to support care delivery as well as enhancing her own learning as part of her elective placement in her final year of study

Malawi local activities

1. Successful attainment of international NGO Registration from Ngora for Village Foundations, this will facilitate opportunities within Malawi previously not available to the Charity
2. Plans were finalised for upgrading the current healthcare clinic to a Dispensary, key stakeholders were engaged to ensure support for the venture, as well as the funding required to commence the build.
3. Lennie Chembezi was recruited as volunteer Administrator. This has released clinical time for Zoe Lawrence to further develop the health care programme

4. District Nursing Programme developed and implemented, travelling to approximately 7 other villages surrounding Mwanyama, offering care and support to families in their locality and who need more intensive support than once per week at the clinic
5. Jon Thornton (CEO) & David Townsend (Trustee) visited Malawi at the beginning of the year, and took with them 2 suitcases full of medication and supplies for VF clinic, kindly donated by UK sponsors
6. With the increase of supplies and medication, VF now receives approximately 150-200 patients each Thursday. VF, by providing financial support to the nearby Monkey Bay Community Hospital, facilitates 8 team members (*including nurses and district officers*), to visit Mwanyama each week to see to patients travelling in from across 7 villages in the region.
7. The VF nursery continues to offer its 30 children much needed education, preparing each child for the village primary school. As part of its service to the nursery VF provides financial support for food to each child, for each day they attend the nursery (*porridge and fruit*)

Other activities

1. Village Foundations continued to support 16 orphans from Myanmar with much needed food, clothing, and educational resources
2. VF also contributed financially towards the building of a hospital in India
