The Charity makes grants from its investment income in furtherance of its Objects.

The Charity's Grant Making Policy: each trustee may suggest potential beneficiaries which are recognised or excepted charities whose aims and operations are consistent with Christian teaching, but which may serve, support or help people regardless of creed, culture or age. Grants may be paid to local Churches, to individuals to meet known needs and to registered charities which enable the recipients to maintain and extend their work serving their communities for the benefit of people in need. Wherever possible trustees maintain contact with beneficiaries to understand how our grants are used.
