## 2. Structure, Governance and Management

The PSA is an unincorporated association governed by a constitution adopted on 10 June 2010. Trustees are elected annually at the AGM.

## 3. Objectives and Activities

The object of the Association is to advance the education of the pupils in the school in particular by:

- Developing effective relationships between the staff, parents and others associated with the school
- Engaging in activities or providing facilities or equipment which support the school and advance the education of the pupils

This is achieved through various activities through the year, including (but not limited to) fairs, discos, social evenings, raffles, lottery, uniform sales and cake sales.

## 4. Public Benefit Statement

Trustees confirm compliance with public benefit guidance. Activities support children and community cohesion.

## 5. Achievements and Performance

Total income for year ending 31 August 2025 was £34,904.59 and expenditure £40,563.54.

The lottery continued to grow, raising c.£2,000 during the period. Donations received (via sponsored event and otherwise) totaled c.£4,000. Major events included the summer and winter fair, raising c.£10,000 combined, sales of second hand uniform, and the annual school disco.

Material expenditure during the year included funding an outdoor classroom in the school grounds (at a cost of £28,000).

## 6. Financial Review

Income: £34,904.59; Expenditure: £40,563.54. Reserves held to support ongoing activities.

## 7. Plans for Future Periods

Plans include further fundraising events.

Future fundraising targets include provision of a new audio system for the school hall and replacement of interactive whiteboards in classrooms.
