When a vacancy arises on the board and a skill is identified, nominees may then be nominated to the board. Induction of new members and training of existing members are conducted at 2 meetings each year.

ACHIEVEMENT & PERFORMANCE

During the year, the charity embarked on a series of activities designed to promote the effectiveness of its objects. The programmes were open to the general public. The programmes were: hospital visits; prayer support, Sunday services and counselling.

Volunteers

Many of our church members volunteer to help in all the different areas of our community outreach programmes. We have approximately 15 volunteers who work an average of 2 hours per week.

FUTURE DEVELOPMENTS

The charity intends to expand its outreach activities to other communities. It is the aim of the trustees to acquire its own property. This will enable it to carry out its outreach activities effectively.

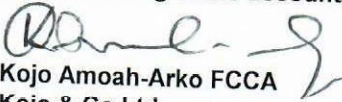
Independent examiner's statement
