The trustees, who are the charity's directors for the purposes of company law, have pleasure in submitting the Report and Accounts for the year ended 30 September 2025

Objects of the charity

Christ Church Derby is a charitable company limited by guarantee and is governed by its memorandum and articles of association dated 6th August 2010. The objects of the charity, as set out in the governing document are

a) to advance the Christian faith in accordance with the Statement of Beliefs in such ways and in such parts of the United Kingdom or the world as the Trustees from time to time may think fit;

b) to relieve sickness and financial hardship and to promote and preserve good health by the provision of funds, goods or services of any kind, including through the provision of counselling and support in such parts of the United Kingdom or the world as the Trustees from time to time may think fit; and

c) to advance education in such ways and in such parts of the United Kingdom or the world as the Trustees from time to time may think fit.

The trustees note that the Church is not a building, but a gathering of ordinary people of different ages and backgrounds, whose lives have been changed by Jesus Christ, the Son of God. The New Testament reveals the Church as a community of people, properly taught and cared for, who by loving and serving Jesus Christ, were also committed to love and care for each other and to bring a blessing to the area in which they lived. Christ Church Derby; its trustees, elders and members are committed to the restoration of those New Testament principles. It is not alone in this, it is one of many Churches in the area, country and all over the world that is re-discovering the excitement of knowing Jesus Christ. The vision is to see the people of Derby and indeed the UK and to the far ends of the Earth come into this experience of knowing Jesus as their Lord, Saviour and friend.

Summary of the charity's main activities and achievements

To further the above objects and vision, the charity's main activities and achievements were as follows:

A) Sunday Services

We continued meeting at 10:45am and 6:00pm on Sundays, along with morning services on Christmas Day and Good Friday. Regular morning attendance varies between 70-100, including c25 children; evening attendance is c40, including a handful of children. We continued to welcome a notable number of new regular attenders from the local area, including internationals.

B) Midweek meetings

Every Wednesday, CCD meets together from 7.30-9pm for fellowship, prayer and study either at Great Northern Road or in homes in smaller groups called 'Community Groups'. There are four Community Groups consisting of approximately 75% of the congregation.

C) Events

In October 2024, we held a children's holiday club during the half term along with a special service on the Sunday. The holiday club served a significant number of local children. In December 2024, we held an afternoon carol service event for regular attenders, guests and visitors. In February 2025, the church held a ladies 'swap shop' for church regulars and guests. In September 2025, the church also began a fortnightly ladies' Bible study. Several times during the year, the church held lunches after the morning service to build community in the church and welcome guests and visitors.

D) Young people's Work

We have continued to run our teaching and activity groups for primary and secondary aged children on Sunday mornings at 10:00am. The primary aged group delivered a gift to the local foodbank in October 2025. We have continued to run the 'Connect' group for secondary age young people on alternate Friday evenings.

E) Missionary Support

We continued our partnerships with Mission Partners around the World in Kosovo, Madagascar, Papua New Guinea and North Africa. In particular, the church was able to send financial support of £24,875 (2024: £0) to Trinity College in Myanmar. Trinity College, formerly known as Dai College, is an evangelical theological institution training local Christians to teach and preach the word of God. Trinity College is a Mission partner of the church and one of our Elders and Trustees has visited the college in past years and is in regular contact with the partners at the college.

F) Deacons

The deacons have continued to maintain a bank of basic food and personal items for those in immediate need, and developed an ongoing partnership with the local foodbank. They also continued the 'Boxes of Joy' Christmas initiative in partnership with 2 local schools, gathering and distributing Christmas foodstuffs to local families.

Future Plans

Christ Church Is looking forward to having Ben Alexander join us as Associate Minister in December 2025, with the aim of expanding our outreach and discipleship as well as growing leadership and teaching capacity. The church also intends to continue its 'Boxes of Joy' initiative with local schools, and it's Christmas carol service event. In January, the church is planning to hold a parenting day in partnership with the organisation Growing Young Disciples.

The trustees are also looking to convert from a Charitable Company to a CIO as soon as possible.

In planning the activities the Trustees have applied the guidance on public benefit issued by the Charity Commission.

Volunteers

Most of the charity's activities are undertaken by volunteers and the charity could not operate effectively without their efforts.

Structure, Governance and Management

Responsibility for making operating decisions rests with the trustees who meet regularly to monitor the activities of the charity. New trustees are recruited and appointed by the existing trustees, by a majority vote.

Joel Kendall who is a director and trustee was employed full-time as Church Minister.

Christ Church Derby is a congregation of the International Presbyterian Church and is a member of the First IPC Presbytery of the Uniter Kingdom. The International Presbyterian Church is a Reformed Church with congregations in the UK, Europe and Asia. The government of the church is Presbyterian.

Financial review

During the year income decreased by £46,264, to £148,125 and expenditure increased by £52,025, to £252,112. This is mainly due to the churches support of a church plant in Coventry in 2024 and a change in accounting policy to depreciate the church building, resulting in a higher depreciation expense this year than would normally be expected. As a result the deficit for the year increased by £98,289, to £103,987 and the charity's net assets decreased by the same amount, to £377,607.

Reserves policy

The trustees have determined that the charity should aim to hold unrestricted cash of no less than £30,000 (which equates to about 3 months' of unrestricted expenditure) so that the charity could continue to operate should income and / or expenditure vary adversely. At the year end, the charity held unrestricted cash of £71,206 and the charity is complying with its reserves policy.

Going concern

After reviewing the Church budget, the Trustees have a reasonable expectation that the Charitable Company has adequate resources to continue in operational existence for the foreseeable future.

Key risks and uncertainties

The charity is exposed to various risks - be they operational, financial or reputational. The trustees review the charity's activities regularly to identify significant risks and, where possible, they take appropriate measures to mitigate those risks.

Responsibilities of trustees under company law

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

INDEPENDENT EXAMINER'S REPORT

TO THE TRUSTEES OF

Responsibilities and basis of report

As the charity’s trustees of the Company (and also its directors for the purposes of company law) you are responsible for the preparation of the accounts in accordance with the requirements of the Companies Act 2006 (‘the 2006 Act’).

Having satisfied myself that the accounts of the Company are not required to be audited under Part 16 of the 2006 Act and are eligible for independent examination, I report in respect of my examination of your charity’s accounts as carried out under section 145 of the Charities Act 2011 (‘the 2011 Act’). In carrying out my examination I have followed the Directions given by the Charity Commission under section 145(5) (b) of the 2011 Act.

Independent examiner’s statement

1 Statutory Information

The charity is a charitable company limited by guarantee and is incorporated in the United Kingdom. The company's registered number and registered office address can be found on the Company Information page.

2 Accounting Policies

These financial statements are prepared on a going concern basis, under the historical cost convention.

These financial statements have been prepared in accordance with the "Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) ("the Charities SORP"), with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland ("FRS 102"), with the Companies Act 2006 and with the Charities Act 2011. The charity meets the definition of a public benefit entity as set out in FRS 102.

The principles adopted in the preparation of the financial statements are set out below.

a) Going concern

The trustees (who are the charitable company's directors for the purposes of company law) have assessed whether the use of the going concern basis is appropriate and have considered possible events or conditions that might cast significant doubt on the ability of the charity to continue as a going concern. The trustees have made this assessment for a period of at least one year from the date of approval of the financial statements. In particular the trustees have considered the charity's forecasts and projections and the possible implications should projected income and / or expenditure vary unexpectedly. The trustees have concluded that there is a reasonable expectation that the charity has adequate resources to continue to operate for the foreseeable future. The charity therefore continues to adopt the going concern basis in preparing its financial statements.

b) Income

Income including investment income is recognised in the period in which the charity becomes entitled to receipt, the amount receivable can be measured with reasonable certainty, and receipt is probable. For the most part, income is generally recognised when it is received. Income is only deferred when the charity has to fulfil conditions before becoming entitled to it or where the donor has specified that the income is to be expended in a future period.

Income from donations includes:

- i) Recoverable gift aid. This is recognised when the related donation is received. Gift aid that has not been recovered by the balance sheet date is included as a debtor.
- ii) Donated facilities, services and goods. Goods donated for distribution to beneficiaries are recognised as income when receivable at fair value (being an estimate of the amount it would cost to purchase those items). Facilities, services and goods donated for the charity's own use are recognised as income when receivable at their value to the charity.

The charity relies on volunteers to carry out many of its activities. However, in accordance with the SORP, the value of these services has not been included in these financial statements as they cannot be reliably measured.

When donated goods, services and facilities are distributed or consumed, an expense in respect of those items is included in the Statement of Financial Activities. At the year end any goods that have not been distributed or consumed are recognised as stock; donated fixed assets are capitalised.

- iii) Legacies. Income from legacies is recognised when a distribution is received from the estate or, if earlier, when the charity has been notified that a distribution will be made and the amount receivable can be measured reliably.

Income from charitable activities represents income receivable from goods, services and facilities supplied in furtherance of the charity's charitable objects.

Income from other trading activities represents income receivable from activities undertaken to generate funds for the charity.

Investment income represents income generated by the charity's assets and includes income from letting the charity's property and bank interest.

c) Expenditure

Expenditure, including irrecoverable VAT, is recognised when it is incurred or, if earlier, when a legal or constructive obligation for a payment arises provided that it is probable that settlement will be required and the amount of the obligation can be measured reliably.

The charity makes grants to other institutions and individuals to further its charitable objectives. Grants payable are recognised as constructive obligations arise, which is generally when the charity expresses a commitment to the recipient that can be measured reliably and then only to the extent that any conditions associated with the grant are outside of the control of the charity.

Governance costs, which are included in expenditure on charitable activities but are identified separately in the notes to the accounts, includes costs associated with the independent examination of the financial statements, compliance with constitutional and statutory requirements and any other expenditure incurred on the strategic management of the charity.

d) Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity. Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes. Restricted funds are donations which are to be used in accordance with specific restrictions imposed by donors; they include donations received from appeals for specific activities or projects.

e) Tangible fixed assets

Items purchased or donated for the charity's own use are capitalised when the cost of purchased items, or the fair value of donated items, is more than £2,000 and the item is expected to benefit the charity over more than one accounting period. Depreciation is charged on a straight line basis so as to write down the value of each asset to its estimated residual value (if any) over its expected useful economic life. To achieve this objective the following rates of depreciation are charged:

Freehold buildings	Over 50 years after taking account of the building's residual value
Equipment	Over 3 to 7 years

The carrying values of tangible fixed assets are reviewed for impairment in periods when events or changes in circumstances indicate that the carrying value may not be recoverable.

f) Pension scheme arrangements

The charity operates defined contribution pension schemes for its employees. Obligations for contributions to these schemes are recognised as an expense when the liability arises. The assets of these schemes are held separately from those of the charity in independently administered funds.

g) Taxation

The company is a registered charity; it has taken advantage of the various reliefs from taxation available to charities and no tax is payable on the charity's income.

h) Financial instruments

The charity's financial assets and financial liabilities all qualify as basic financial instruments, as defined by FRS102. Except for loans, creditors and debtors are measured at their expected settlement value (normally the amount of cash that the charity expects to pay or receive). The charity recognises liabilities for the principal of those loans that remains outstanding at the year end (i.e. the liabilities exclude any interest chargeable on the loans in future years).

i) Exemption from preparing a cashflow statement

The charity has taken advantage of an exemption conferred by the Charities SORP and has not prepared a cash flow statement.

j) Critical accounting estimates and areas of judgement

The trustees do not consider that there are any material sources of estimation or uncertainty at the balance sheet date that could result in a material adjustment to the carrying values of assets and liabilities in the next reporting period.

We welcomed 7 new adult members and said goodbye to 7 members along with 3 other regular attenders. We have continued to welcome a notable number of new regular attenders, including internationals.

B) Wednesday Night Central/Community Groups

Every Wednesday, CCD meets together from 7.30-9pm for fellowship, prayer and study either at Great Northern Road or in homes in smaller groups called 'Community Groups'. There are four Community Groups consisting of approximately 75% of the congregation.

C) Evangelistic Events

In October 2023, we held a children's holiday club during the half term along with a special service on the Sunday. In December, we held a morning family carol service and an evening carol service. We have also continued to hold 'Taster Sundays' each term.

D) Children's Work

We have continued to run our teaching and activity groups for primary aged children on Sunday mornings at 10:00am. These groups have also enjoyed a Harvest Sunday, including a trip to deliver a gift to the local foodbank, in October 2023. We have continued to run the 'Connect' group for secondary age young people on alternate Friday evenings. October 2023 saw the beginning of 'Connect Plus' for secondary age young people on Sunday mornings before the church service.

OTHER NEWS

A) Missionary Support

We continued our partnerships with Trinity College in Myanmar, the Watts family in Madagascar, the Byrne family in north Africa, the Moxon family in Kosovo, and Rob Jones in the USA.

B) Staff & leadership

ACTIVITIES

A) Sunday Services

During September 2021, we ceased meeting at 4pm on Sundays, and began to meet twice at 10:45am and 6:00pm, along with morning services on Christmas Day and Good Friday. Regular morning attendance varies between 65-90, including c25 children; evening attendance is c40, including 5-10 children. We welcomed 8 new adult members and said goodbye to 3 members. We have continued to welcome a notable number of new regular attenders, including internationals.

B) Wednesday Night Central/Community Groups

Every Wednesday, CCD meets together from 7.30-9pm for fellowship, prayer and study either at Great Northern Road or in homes in smaller groups called 'Community Groups'. There are four Community Groups consisting of approximately 75% of the congregation.

C) Evangelistic Events

Covid restrictions during the earlier part of the year limited our opportunities to hold events to engage the community and give people the opportunity to find out about the Christian faith. In December 2021, we delivered flyers to the local area and held an all age morning carol service along with our normal carol service in the evening.

D) Children's Work

In September 2021, we began running teaching and activity groups for primary aged children on Sunday mornings at 10:00am. These groups have also enjoyed an Easter Egg painting competition in April 2022, a picnic in May, and prizes in July. We also began running a group for secondary age young people on alternate Friday evenings called 'Connect'.

OTHER NEWS

A) Missionary Support

We continued our partnerships with Trinity College in Myanmar, the Watts family in Madagascar, the Byrne family in north Africa, and the Moxon family in Kosovo.

B) Staff

Joel Kendall has continued to serve as Minister. Peter Leach has continued to serve as Assistant Minister, and in May 2022 he completed his theological studies began to be employed on a full time basis.

C) Deacons

In August 2022, we ordained 3 new deacons in order to grow our practical care in the congregation and service to the local community.

FINANCIAL INFORMATION

Total receipts of unrestricted funds were £122,286 and no restricted funds were received.

We spent £111,288 on our ministry throughout the year. Therefore, the net result of receipts over expenditure for the year was £10,998.



EXTRAORDINARY EVENTS

A) Covid-19

At various points during the year, the UK government imposed nationwide social restrictions due to the ongoing Covid-19 pandemic. This resulted in the suspension of Sunday and midweek church gatherings during November 2020, and other forms of restriction at other times. During the lockdown, Sunday worship and teaching were provided via livestream, and Community Groups, midweek prayer gatherings, and other midweek teaching were conducted via Zoom. The Sunday school leaders also produced a Sunday morning activity for the children via Zoom. When it was possible to meet in person, and when restrictions were largely relaxed in July 2021, we continued to livestream services for the sake of those who had to remain in isolation.

The Trustees took the following additional actions:

- Regularly reviewed the church financial situation, in particular income levels.
- Sent a finance update to the church, which included an encouragement to get in touch in the event of financial difficulties.
- When gatherings resumed, various procedures were implemented to ensure the church adhered to legal requirements and minimised risk for attenders. Each activity was risk assessed before it resumed.

ACTIVITIES

A) Sunday Services

We have continued to meet at 4pm on Sundays, along with morning services on Christmas Day and Good Friday. Regular attendance from October 2020 to June 2021 was consistently in the 50s (c 40 adults and 15 children). From June 2021 attendance began to climb into the 70s (c 55 adults and 20 children) We welcomed 8 new members and said goodbye to 7 members, 1 of whom passed away during the year. This year we have welcomed a notable number of regular attenders who have been investigating the Christian faith.

B) Wednesday Night Central/Community Groups

Every Wednesday, CCD meets together from 7.30-9pm for fellowship, prayer and study either at Great Northern Road or in homes in smaller groups called 'Community Groups'. There are four Community Groups consisting of approximately 75% of the congregation.

C) Mums' Bible Study

During Covid restrictions, the mums' Bible study met weekly informally and via Zoom. From July 2021, they began to meet again in the church building at Great Northern Road. It is organised by Kathryn Kendall and Helen Newbould. The number of mums in the church continues to increase, and so this remains a vital and growing part of our ministry.

D) Evangelistic Events

Covid restrictions limited our opportunities to hold events to engage the community and give people the opportunity to find out about the Christian faith. In October 2020, we provided a video holiday Bible club resource for children, and in December we delivered flyers to the local area and livestreamed our carol service.

OTHER NEWS

A) Missionary Support

We continued our partnerships with Trinity College in Myanmar, the Watts family in Madagascar, the Byrne family in north Africa, and the Moxon family in Kosovo.

B) Staff

Having been with us as a Ministry Student since September 2020, Rob Jones left in June 2021 for theological training in the USA.

In February 2021, Peter Leach joined us as Assistant Minister, along with wife Libby and new daughter Sarah. He is initially working on a 2/3 time basis until his theological studies are complete, when he will be employed full time.

FINANCIAL INFORMATION

Total receipts of unrestricted funds were £121,436 and no restricted funds were received.

We spent £96,853 on our ministry throughout the year. Therefore, the net result of receipts over expenditure for the year was £24,583.

We aim to keep reserves equivalent to three months' expenditure for emergencies, although at the moment our reserves are higher in order to provide a contingency for expenditure on property in the future as we expand our activities.
