Para 1.20	The charity has achieved its initial objective of establishing a treatment centre for children suffering from cerebral palsy and related disabilities, and recently added a small bedsit for use by families who have travelled large distances for treatments. The trustees ongoing objective is to continue raising funds to meet ongoing running costs and for new equipment to enhance the treatments available, and improve outcomes for the children. During the year the physiotherapy centre had to close twice due to the lockdowns, and when open had to operate at reduced levels, due to coronavirus restrictions, which has obviously disrupted the assessments and treatments via its subsidiary. The latest reopening was on 22 nd March 2021, and we have remained open since then.

Performance of fundraising activities against objectives set	Para 1.41	The charity usually undertakes several fundraising events including an annual charity ball, and several charity golf days, which have always been well supported. Coronavirus restrictions resulted in the cancellation of most of these events, and also impacted on our many supporters who run marathons and undertake other sponsored activities. In addition other charitable bodies that might normally be a source of funding, suffered from the restrictions on their own fundraising activities, which inevitably fed through to the charity. The charity also receives numerous donations from individuals and local businesses, which despite their own difficulties have largely maintained their support during the year. Our supporters are too numerous to mention individually, but all donations are gratefully received and put to good use in

		providing treatments in the physiotherapy centre.

The charity's principal sources of funds (including any fundraising)	Para 1.47	The activities of our volunteers are too numerous to go through individually, but include sponsored runs, golf days, bike rides, and charity fun days, which are beginning to take place again, and should provide some funding for the coming year. The charity also hopes to run its usual fundraising events for the coming year, after these were largely cancelled for the year under review. The trustees are grateful to have been supported by other charitable organisations, despite the difficulties they faced themselves, including notably Sisters of the Holy Cross £20,000, and Wooden Spoon £3,500. In addition the charity has received support from numerous local businesses and organisations, who have raised awareness of the charity and its activities, in addition to generously donating money. The trustees would in particular like to thank everyone who has continued to raise money and donate to the charity in the current year despite the impact of Coronavirus on their lives and organisations.

This risk has been mitigated by the use of professionally qualified physiotherapists, insurance, and operating the physiotherapy centre in a separate subsidiary limited company.
Other		Coronavirus meant the closure of the physiotherapy centre for much of the financial year, and when open operating at reduced capacity. The trustees took all available steps to reduce overheads and make use of government assistance to safeguard the charity assets and ensure that the centre was ready and able to reopen as and when permitted. The centre last reopened on 22 nd March 2021, and has remained open since the year end providing assessments and treatments. Fundraising activities have been severely curtailed in the year, with many events having to be cancelled; however our donors and supporters have remained very supportive in these difficult times, for which the trustees are very grateful.





