Para 1.20	The charity has achieved its initial objective of establishing a treatment centre for children suffering from cerebral palsy and related disabilities. The trustees ongoing objective is to continue raising funds to meet ongoing running costs and for new equipment to enhance the treatments available, and improve outcomes for the children. During the year the physiotherapy centre continued to offer treatments to children in need, but upward cost pressures meant that the grant required from the charity was sharply increased for the year. Despite the increase in the grant required to operate the centre, donations were up in the year by an even larger amount, and therefore the charity recorded a cash surplus excluding depreciation of £33,800, which has been added to reserves.

Performance of fundraising activities against objectives set	Para 1.41	The Charity's usual programme of events were carried out in the year, and our many supporters who run marathons and undertake other sponsored activities continued to raise funds. The charity also continued to receive numerous donations from individuals and local businesses, whose community support is invaluable. There were many larger grants from charity fundraisers and supporters, and the charity was chosen as charity of the year for 2 local golf clubs, who raised over £68,000. The trustees continue to engage with all donors and to seek funding for the charity. Our supporters are too numerous to mention individually, but all donations are gratefully received and put to good use in providing treatments in the physiotherapy centre.

The trustees are of the opinion that the current operational cash requirement is approximately £150,000 per annum. Coronavirus obviously impacted the charity finances, and the trustees had to utilise reserves to see the charity through the lockdowns and restart activities. The trustees are now working hard to rebuild reserves to meet their policy objective, whilst managing the significant adverse costs pressures as best they can.
