Trustee's Report

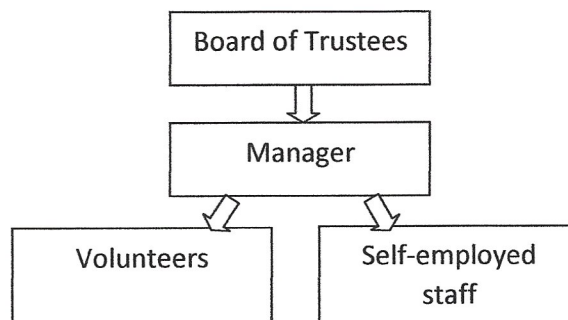
The trustees present their report with the financial statements of the company for the period ended 31 August 2023.

Principal Activities

- To train and mentor young people in the theatrical arts.
- To support families on low income by providing youth theatre at low cost.
- To improve arts provision in the local rural community.
- To create jobs for local artists.

Management

The organisation is run by a board of trustees under the guidance of our Constitution. They devolve much of the everyday running to the person appointed "Manager". The trustees oversee all policy documentation, finances and important company decisions. They aim to meet every quarter to discuss these matters as well as on an ad-hoc basis when needed. The Manager is a paid person who reports to the trustees on every day running. Currently, due to the small size of the charity, this is also a trustee, but they are NOT paid for any trustee activities, only for every day running that goes above and beyond the expectations of a trustee.

Trustee & Staff Recruitment

Trustees are appointed either because there is a gap and so one is sought out, or because someone approaches the group to help. In both instances, the current trustees would discuss their suitability and meet with them to decide if they are a good fit for the needs of the charity. When a new member of staff is needed, the group puts an advert in various

appropriate places and receives applications, and on the back of this conducts interviews. All new members are required to be DBS checked and undergo relevant training.

Some Key Achievements for 2023

- We provided theatre opportunities to 55 children, teaching them creative, team-working, problem-solving and communication skills, as well as giving them the chance to perform onstage and build confidence.
- We supported 12 children from low-income families through our youth theatre programme.
- We have worked with looked-after children, service children, home-schooled children and many with additional needs. Some of these students have gone on to get distinctions in exams and onto courses they feel they wouldn't have otherwise got into, so we feel proud of the skills we have helped them gain in order to support other areas of their lives.
- We presented quality theatre to the local community, within walking distance for a rural area that doesn't have much theatre, to roughly 350 people.
- We provided work for local self-employed artists, including training some young people under 25 in their first roles.

Performance

We invested a lot on keeping students and families engaged during Covid, which paid off, as while we made a loss during the 20-21 year the proceeding years picked up again and were much more even. This year was our biggest financially yet, hitting the over £25,000 for both income and expenditure for the first time ever.

Objectives for 2024

To continue to offer low-cost opportunities to those from all backgrounds, and provide quality theatre to those in rural areas.

Despite this however, and after much discussion, the trustees have taken the decision that the work of the youth theatre would be better undertaken by a non-profit Community Interest Company arm, whilst the charity itself focuses on those needing subsidies.


Financial Review

This financial year has shown around a 25% increase in turnover (though the previous year in itself was a drop after Covid). Expenditure and profit remain similar figures in line with our not-for-profit status. Reserves have increased slightly (if the charity should fold, this goes to a charity completing similar work in line with our Constitution). No funds are held by a custodian trustee, apart from briefly after a production, when less than £500 is taken in cash and deposited in the bank.

After scrutinising the accounts with the independent examiner, it was noted that our filed accounts for the end of FY2022 were reported slightly incorrectly due to the month end being wrong. Also some ledgers were updated to change the category of some inputs. Please see corrected accounts in this report.


Independent Examiner's Statement
