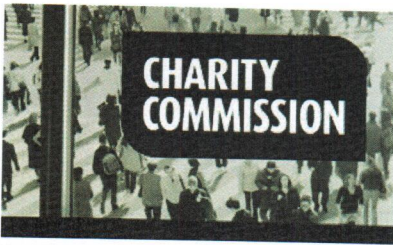

Independent Examiner's Report to the trustees/members of Wistow All Saints Heritage Appeal.

Report by an independent examiner of the financial statements for the year ending 31st December 2024, prepared by the Wistow All Saints Heritage Appeal, North Yorkshire.
