No trustee received any remuneration nor reimbursed any expenses in the year under review.

During the year under review Coutts & Co, a trustee of the charity to February 2022, were paid fees for the provision of administration and investment management services amounting to £9,915 whilst a trustee. These fees are authorised under clause 6 of the trust deed.
