How is the charity constituted?	Trust
Trustee selection methods including details of any constitutional provisions e.g. election to post or name of any person or body entitled to appoint one or more trustees	The Trustees as Charity Trustees are responsible for the management and administration of the Church's property and funds in accordance with this Constitution. There shall be at least four and not more than eight Trustees. They shall be spiritually mature Members of Hebron. If the number of Trustees in post reduced to less than 4, by the departure of a Trustee for any reason, those remaining Trustees should, as soon as possible take steps to commence a process for appointing a new Trustee to act in an interim capacity, by inviting nominations from the membership. This appointment would be subject to approval by members at a Special Church Meeting and subsequent ratification at the subsequent Annual General Meeting. Trustees are to be elected at an Annual General Meeting. They shall normally serve a term of 3 years and shall thereafter be eligible for re-election.
