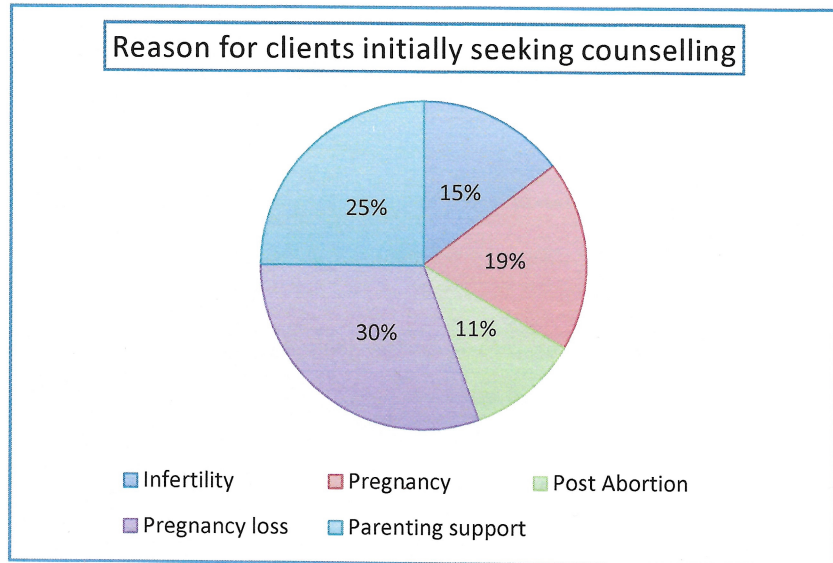

Achievements and Performance

Between 1 May 2022 and 30 April 2023, CPCP provided counselling and psychotherapy to 144 clients, averaging 25 counselling sessions per client.

Pregnancy loss continued to be the most common reason for clients initially approaching CPCP for counselling and psychotherapy (30%) followed by support during early years parenting (25%) and pregnancy (19%).

These initial figures however cover a more complicated reality, which is that a significant number of clients (over 10%) required support in relation to two or more issues over the period in which they received counselling, for example, suffering a pregnancy loss after having initially sought counselling in relation to a pregnancy or becoming pregnant after having previously suffered a pregnancy loss.



The charity’s integrated therapeutic model and its clinical excellence, flexibility and holistic approach enables continuous, appropriate and high-quality support to its clients, including those who are suffering from multiple pregnancy- and parenting related issues, often caused by longstanding underlying psychological trauma. The charity’s experience and expertise is reflected in the fact that a substantial percentage of its clients continue to be referred by hospitals and health professionals such as midwives, GPs and health visitors (13%), the NHS Access to Talking Therapies programme (42%), and other charities working in the field, such as the Miscarriage Association, SANDS and the Birth Trauma Association. Clients continue to be able to access the charity directly (in the year to 30 April 2023, 41% of clients self-referred).

The Trustees are grateful to the BACP for its ongoing overview and guidance, which is essential in achieving the charity’s aim of making high quality specialist counselling available to all in need, regardless of ability to pay. They also wish to recognise the work of the Therapy Manager in maintaining CPCP’s accreditation with the BACP and the feedback that she received from that body, which recognised her work as evidencing a high professional standard of clinical practice.

Most importantly, CPCP’s clients continue to affirm its positive impact upon their lives. The following testimonial was received from a client whose counselling came to an end during the year:





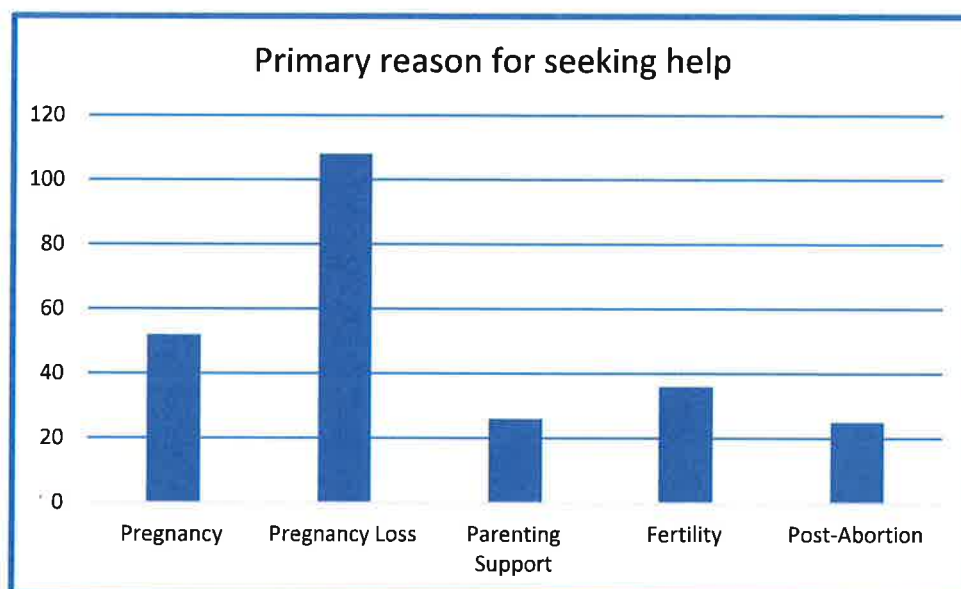

Achievements and Performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole (SORP Para 1.20).

In the period 1 May to 30 April 2021, CPCP provided counselling and psychotherapy to 247 clients, an increase of 8% from the previous year. Due to the ongoing coronavirus pandemic, all counselling continued to be provided remotely rather than face-to-face. With each client being seen for an average of 16 weeks, that equated to the provision of 3,952 counselling sessions for this group of clients as a whole. Pregnancy loss (miscarriage, stillbirth or ectopic or molar pregnancies) was by far the most frequent primary reason why clients sought help from CPCP (108 clients). Difficulties connected with pregnancy was the second most frequent reason for clients seeking help (52 clients), with such difficulties spanning issues such as unplanned pregnancy, previous traumatic birth experience, ante-natal depression and anxiety, or a need for emotional and mental support for other reasons.



The counselling at CPCP is provided by our Therapy Manager, who is accredited by the British Association of Counselling & Psychotherapy and a dedicated team of fifteen volunteer counsellors who are either fully qualified or in training. The charity is itself accredited by the BACP, being first accredited in 2015 and in August 2020 achieving a further five-year accreditation. In achieving accreditation, we have demonstrated to the BACP's satisfaction that the service provided at CPCP is accountable, ethical, professional, and responsive to the needs of our clients, staff, and volunteers.

To best support our therapists, and in line with BACP requirements, we provide them with regular clinical supervision, to help them to safeguard their own emotional and mental wellbeing, and to ensure that they adhere to clinical best-practice in their work with our clients. CPCP also helps its staff and volunteers to develop as therapists by providing them with training on topics relevant to our mission. It became clear to us early on in the pandemic that clients were experiencing significantly greater levels of anxiety and trauma and therefore the training during this period focused on different aspects of trauma, including Post Traumatic Stress Disorder.

We believe that this focus on caring for our staff and volunteers leads to the best possible outcomes for our clients, and the measures that we use to measure our impact bear this out.

When clients have finished their counselling with us, they are asked to return (on an anonymous basis) forms evaluating their experience at CPCP. To the end of 2021, of the 375 forms returned to that date:

- 65% of clients thought that the counselling had helped them fully, and 34% thought that it had helped them in part.
- 92% of clients thought that their counsellor had been excellent at listening to them.
- 85% of clients thought that their counsellor had been excellent at understanding their issues.
- 80% of clients strongly agreed that their counsellor had worked with them to address their difficulties.
- 91% of clients thought that their counselling had helped them to understand their relationships.
- 84% of clients thought that their counselling had helped them to improve their relationships.

As a second way in which we measure the impact the counselling provided by CPCP has on the well-being of our clients, we also use the CORE Outcome Measure, a clinically-validated tool which assesses therapeutic impact on a more quantitative basis. Such analysis confirms a significant decrease in the level of psychological distress suffered by our clients following therapy at CPCP.



