CHARITY SUCESSSES AND ACHIEVEMENTS THIS YEAR

For the 2024-25- year, Stage Theatre Society moved to the model of doing one production per annum. It was considered in the previous year from volunteers, that the group should look to ease the pressure that comes from staging two productions per year. Now that this is in place, this has been well received by all involved with helping for the productions. This has also reduced both the time and storage pressures that were being experienced.

Now that this is in-place it has allowed to group to turn some focus to bringing back more of the extra-curricular activities that the group used to enjoy.

Following the success of Matilda the Musical, and moving to the one show per year model, the show this year was Our House the Musical. Over the years Stage Theatre Society has enjoyed performing such a wide variety of productions – and Our House was produced by us way back in 2011 – So, for many of the volunteers that have been with the group for years, this was a real blast from the past.

The show was a great success and further raised the bar from the 2011 production. The cast and crew enjoyed being part of the production and the audience gave rave reviews.

RESERVES POLICY

Although a move to one production per annum has been put in place, Stage Theatre Society aims to keep reserves of £4000. With general costs increasing over the years, this has been assessed as an amount that can meet the charity's needs by the Governing Body. This will meet one year's minimum expenditure should there be a substantial reduction of income to STS.

PRINCIPAL FUNDING SOURCES

Stage Theatre Society principally generates funding from Ticket Sales / Donations for productions and membership subscriptions. These will continue to be the principal sources of income to the group for the foreseeable future.

As we moved into the 2023/24-year, Stage Theatre Society has begun to look at shaping its work for the future. It was considered this year from volunteers that the group should look to ease the pressure that comes from staging two shows per year. For all involved in the background, the work required to put on the shows is ever increasing. Alongside this, incidentals such as the storage of costumes, props and set are also becoming a challenge.

It is with the above in mind, to keep the volunteers that we have, that we decided to move to a model of performing one show per year. This would bring with it both reduced time and storage pressure. It was also recognised that with the longer time to produce a show, we could turn our attention to more extra-curricular activities along the way.

This year, following the production of 'The SpongeBob Musical' we started rehearsals for The Little Mermaid Jr. The show was not only a success but presented some new challenges in the way we created set and props for a production that was underwater. The cast enjoyed being involved with the production, the team enjoyed staging it and audiences enjoyed the production -giving great reviews.
