Objects: (A) TO FURTHER OR BENEFIT THE RESIDENTS OF LEEDS AND THE SURROUNDING AREA, WITHOUT DISTINCTION OF SEX, SEXUAL ORIENTATION, RACE OR OF POLITICAL, RELIGIOUS OR OTHER OPINIONS BY ASSOCIATING TOGETHER THE SAID RESIDENTS AND THE LOCAL AUTHORITIES, VOLUNTARY AND OTHER ORGANISATIONS IN A COMMON EFFORT TO ADVANCE EDUCATION AND TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND LEISURE TIME OCCUPATION WITH THE OBJECTIVE OF IMPROVING THE CONDITIONS OF LIFE OF THE RESIDENTS. (B) TO OFFER A SAFE FRIENDLY AND NEUTRAL ENVIRONMENT IN LEEDS WHERE CHILDREN OF SEPARATED FAMILIES CAN SPEND TIME WITH ONE OR BOTH PARENTS AND SOMETIMES OTHER FAMILY MEMBERS; (C) TO RELIEVE SICKNESS AND FINANCIAL HARDSHIP AND TO PROMOTE AND PRESERVE GOOD HEALTH BY THE PROVISION OF FUNDS GOODS OR SERVICES OF ANY KIND IN LEEDS AND IN SUCH OTHER PARTS OF THE UNITED KINGDOM OR THE WORLD AS THE TRUSTEES MAY FROM TIME TO TIME THINK FIT.

Activities: The charity is based in Leeds and operates one main project - a Child Contact centre which is accredited by the National Association of Child Contact Centres.
