Members of the committee are appointed from each of the functional areas or sections on the unit. However, all management decisions, acquisitions and expenditure are subject to the Trustees' approval by signature in the minute book. Committee meetings take place each month. The budget for the next financial year is set in May by the committee for approval by the mess members at a General Meeting.
