(2) THE PROMOTION OF SOCIAL INCLUSION FOR THE PUBLIC BENEFIT BY PREVENTING PEOPLE FROM BECOMING SOCIALLY EXCLUDED, IN PARTICULAR BY THE PROVISION OF COHESIVE COMMUNITY ARTS EVENTS AND ACTIVITIES TO RELIEVE THE NEEDS OF SUCH PEOPLE AND ASSIST THEM TO INTEGRATE AND CONTRIBUTE INTO MAINSTREAM INTO SOCIETY.
