Objects: (A) TO ADVANCE THE HINDU RELIGION FOR THE BENEFIT OF THE PUBLIC PARTICULARLY BUT NOT EXCLUSIVELY THROUGH THE HOLDING OF PRAYER MEETINGS, LECTURES AND PUBLIC CELEBRATION OF RELIGIOUS FESTIVALS; (B) TO PROVIDE AND ASSIST IN PROVIDING FACILITIES FOR SPORT, RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABILITY, FINANCIAL HARDSHIP OR SOCIAL AND ECONOMIC CIRCUMSTANCES IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE; (C) TO ADVANCE THE EDUCATION OF ADULTS, YOUNG PEOPLE AND CHILDREN BY THE PROVISION OF INFORMATION, TRAINING AND SUPPORT TO ENABLE THEM TO DEVELOP THEIR FULL CAPACITIES AND ENABLE THEM TO PARTICIPATE IN SOCIETY AS INDEPENDENT, MATURE AND RESPONSIBLE INDIVIDUALS; (D) TO CARRY OUT SUCH OTHER CHARITABLE PURPOSES FOR THE BENEFIT OF THE PUBLIC AS THE TRUSTEES SHALL FROM TIME TO TIME THINK FIT.

Activities: THE MANDAL WAS ESTABLISHED BY A CONSTITUTION FORMALLY ADOPTED IN 1972. THE AIMS ARE TO ADVANCE THE HINDU RELIGION FOR THE BENEFIT OF THE PUBLIC; TO ACCOMMODATE AND ASSIST IN PROVIDING FACILITIES FOR SPORT, RECREATION OR OTHER LEISURE TIME OCCUPATION TO INDIVIDUALS; TO PROVIDE INFORMATION, TRAINING AND SUPPORT FOR ALL INVOLVED BY DEVELOPING THEIR SKILLS AND ENABLING THEM TO PARTICIPATE IN THE SOCIETY.
