Trustee Report for the Year Ended 31st August 2022

In the year to 31 August 2022, Friends of Kew Green Preparatory Junior School raised £41,650 and made donations of £13,488. Funds at 31 August 2022 stood at £9,264.

Following the lockdowns caused by the Covid pandemic in the previous year, which largely curtailed the charity's activities, this was very much a transition year. The previous year's Summer Fair, postponed due to the pandemic, took place in the Autumn term, after which the Summer Fair returned to its traditional June window. The other major events during the year were the Spring Fling and the Pub Quiz. Bake sales and second-hand uniform sales also resumed.

Donations made in the year included £300 to Guide Dogs for the Blind and £7,522 to Noah's Ark Pink Balloon. The charity also made donations of £5,666 for various initiatives to improve the school environment.

As would be expected for a 'PTA' charity, there were changes in the trustee committee during the year and further changes have been actioned since the year end, these are detailed in the table below. A review of our governance procedures also took place and several improvements were implemented, including the movement of our financial records from a cash basis to an accruals basis (consequently no comparatives have been given in the accounts for the prior year).
