TRAFFICKING IN PERSONS SHALL HAVE THE MEANING GIVEN IN THE UNITED NATIONS PROTOCOL TO PREVENT, SUPPRESS

The relief of girls who may have been the victim of trafficking in particular by providing housing, financial support, legal advice and medical care
Protection of girls from being harmed by trafficking in persons and/or by sexual abuse or domestic violence
