### **Trustees' Annual Report for the year ended 31 March 2025**

The Trustees present their Report and Accounts for the year ended 31 March 2025, which also comprises the Directors' Report required by the Companies Act 2006.

#### **Reference and administrative details**

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the Society's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019).

#### **Objectives and activities**

The Society's objects are to promote the care, treatment and education of children and adults with learning disabilities, by the provision of help and support for them and their families, dependants and carers, commensurate with their needs.

The trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the Society should undertake.

#### **Achievements and performance**

Unfortunately, due to the New Kirtland Centre being in a state of disrepair and due to health and safety issues it is unsafe for service users, volunteers and members of staff to be on the premises. As a number of our members are elderly and clinically vulnerable we made a decision to continue to provide a shopping service to all service users, parents/carers at no cost to themselves. We have a number of volunteers/staff who regularly visit all service users, parents and carers to provide any support required. This support includes accompanying for leisure activities, medical appointments & hospital visits. Our volunteers/staff travel to any borough that requires our support.

#### **Financial review**

It is the policy of the Society that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to between 3-6 months expenditure. The trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the Society's current activities while consideration is given to ways in which additional funds may be raised. Included in these funds are our annual Golf Tournament donations, Christmas raffle. We also received a £500 Grant from Royal Mencap Society. We will continue to pay rent, insurance and utility bills for the New Kirtland Centre whilst continuing getting it ready for use. As The New Kirtland Centre is only being used as a base point and is not usable we have no other income/funding coming in until we fully open.

The Board of Trustees has assessed the major risks to which the Society is exposed, and is satisfied that the systems are in place to mitigate exposure to the major risks. The trustees regularly monitor the risk exposure of the society and action is taken to investigate and mitigate any risks identified.

#### ***Structure, governance and management***

The Society was originally registered as a charity on 4th January 1983 under registration number 286013. The Society adopted a charitable trust deed on 11th November 1982 as amended 26th June 2005. On 10th February 2011 the Society registered as a company limited by guarantee and on 1st April 2011 the activities of the Society were transferred to the charity company under registration number 1142178. The Society has now adopted the Local Model Constitution of the Royal MENCAP Society. The trustees, who are also the directors for the purpose of company law, and who served during the year and up to date of signature of the financial statements were:

The trustees are appointed by the Board of Trustees and serve for five years after which period they may put themselves forward for reappointment.

None of the trustees has any beneficial interest in the company. All of the trustees are members of the company and guarantee to contribute £1 in the event of a winding up.

The trustees meetings are held and at such meetings the trustees agree the Boards strategy and areas of activity for the Society, including consideration of reserves and risk management policies and performance. The Board keeps the skill requirements for the trustee body under review and in the event that a trustee permanently retires or additional new trustees are required, the Board actively recruits the new trustees by advertisement or through a dialogue with associated bodies.

The Society is a member of The Royal Mencap Society (MENCAP). The Royal Mencap Society provides helpful information on good practice, changes in the law affecting charities and acts as an authoritative lobby on behalf of The Mencap Societies with the government regulators.

#### ***Plan for Future periods***

Unfortunately, after now finding further damp and mould due to our water connection there are major works that will need completion in The Kirtland Centre before we can officially open and therefore we cannot apply for any grants or funding at present. Into the future, we hope to open as a daily community hub for those with a Learning Disability as well as for Parents/Carers. We will be applying to local businesses as well as corporate companies for funding and we will continue to rise to the challenge to support both adults and children with Learning Disabilities and Parents/Carers.

### Report of the Independent Examiner to the Trustees of the charitable company on the accounts for the year ended 31 March 2025

I report to the charity trustees on my examination of the accounts of the company for the year ended 31st March 2025 which are set out on pages 6 to 11

#### Respective responsibilities of the Trustees and the Independent Examiner and the basis of the report

As the charity trustees of the Society (and also its directors for the purposes of company law) you are responsible for the preparation of the accounts in accordance with the requirements of the Companies Act 2006 ('the 2006 Act'). Having satisfied myself that the accounts of the company are not required to be audited under Part 16 of the 2006 Act and are eligible for independent examination, I report in respect of my examination of your company's accounts as carried out under section 145 of the Charities Act 2011 ('the 2011 Act'). In carrying out my examination I have followed the Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act.

#### Independent examiner's statement - matter of concern identified

The charity has made guardianship payments, included under establishment costs in the financial statements for the years ended 31 March 2023 and 31 March 2024, amounting to £157,248 and £108,000 respectively.

I requested evidence relating to the most recent cheque issued for such payments (accrued in 2023/24, but settled in 2024/25). It was revealed that the cheque had been banked and subsequently cashed by an employee, who then distributed the funds in cash to individuals providing guardianship (security) services. This method of disbursing cash appears to have been standard practice for all such payments.

I was informed that the distribution of cash was witnessed by both a trustee and another employee.

I have been advised that the trustees have now ceased making guardianship payments and have also discontinued the practice of making such payments in cash.

I confirm that no matters have come to my attention in connection with the examination giving me cause to believe that in any material respect:

1. accounting records were not kept in respect of the company as required by section 386 of the 2006 Act; or
2. the accounts do not accord with those records; or
3. the accounts do not comply with the accounting requirements of section 396 of the 2006 Act other than any requirement that the accounts give a 'true and fair view' which is not a matter considered as part of an independent examination; or
4. the accounts have not been prepared in accordance with the methods and principles of the Statement of Recommended Practice for accounting and reporting by charities [applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)].

I confirm that there are no other matters to which your attention should be drawn to enable a proper understanding of the accounts to be reached.

## Notes to the Accounts for the year ended 31 March 2025

### 1 Accounting policies

#### Basis of preparation and accounting convention

The financial statements have been prepared on the accruals basis, under the historical cost convention, and in accordance with Financial Reporting Standard 102 (FRS 102), effective from 1 January 2016, and the Charities SORP (FRS 102) 2019, applicable to accounting periods beginning on or after 1 January 2019.

The SORP is issued by the Charity Commission for England and Wales (CCEW) and has been applied in accordance with applicable law in the charity's jurisdiction of registration.

Although the Charities (Accounts and Reports) Regulations 2008 refer to the earlier 2005 SORP, which has since been withdrawn, the trustees have adopted the 2019 SORP to reflect current best practice in charity accounting and reporting.

#### Going Concern

The Trustees are satisfied that, at the time of approving the financial statements, there are sufficient resources available to adopt the going concern basis in preparing the financial statements. The Trustees are not aware of any material uncertainties about the charity's ability to continue as a going concern.

#### Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the charity's objectives. Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

#### Incoming resources

Income is recognised when the Society is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received

Cash donations are recognised on receipt. Other donations are recognised once the Society has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation

#### Recognition of liabilities and expenditure

A liability, and the related expenditure, is recognised when a legal or constructive obligation exists as a result of a past event, and when it is more likely than not that a transfer of economic benefits will be required in settlement, and when the amount of the obligation can be measured or reliably estimated.

Liabilities arising from future funding commitments and constructive obligations, including performance related grants, where the timing or the amount of the future expenditure required to settle the obligation are uncertain, give rise to a provision in the accounts, which is reviewed at the accounting year end. The provision is increased to reflect any increases in liabilities, and is decreased by the utilisation of any provision within the period, and reversed if any provision is no longer required. These movements are charged or credited to the respective funds and activities to which the provision relates.

### Notes to the Accounts for the year ended 31 March 2025

#### *Tangible fixed assets*

Tangible fixed assets are measured at their original cost value, or subsequent revaluation. Cost value includes all costs expended in bringing the asset into its intended working condition.

Depreciation has been provided at the following rates in order to write off the assets to their anticipated residual value over their estimated useful lives.

Fixture & Fittings	15 % written down value
Computers	25 % written down value

A regular annual review of asset impairment is undertaken.

#### **Pensions - defined contribution schemes**

The charity operates a defined contribution pension scheme. Contributions are charged to the profit and loss account as they become payable in accordance with the rules of the scheme.

#### **Cash and cash equivalents**

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

#### **Taxation**

The charity is exempt from tax on its charitable activities.

## TRUSTEES' REPORT (INCLUDING DIRECTORS' REPORT)

### FOR THE YEAR ENDED 31 MARCH 2021

---

The trustees present their annual report and financial statements for the year ended 31 March 2021.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the Society's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019).

#### **Objectives and activities**

The Society's objects are to promote the care, treatment and education of children and adults with learning disabilities, by the provision of help and support for them and their families, dependants and carers, commensurate with their needs.

The trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the Society should undertake.

#### **Achievements and performance**

Unfortunately due to Covid-19 Tower Hamlets Society could not run a full service due to our service users falling into the high risk category and having to self-isolate. However, we kept in contact via telephone calls, virtual calls e.g. Zoom and Facetime. In September 2020 a virtual call was made between trustees and it was decided that due to further Covid-19 restrictions we would provide a shopping service to our service users, parents/carers at no cost to themselves and we also made the decision to provide to local food banks.

#### **Financial review**

In June 2020 squatters once again gained access to The Kirtland Centre. Our solicitors once again took legal action to have them removed and they vacated the property in July 2020 after which 24 hour security was put in place until the property was sold.

From April 2020 to August 2020 we were still reliant on Mr Kirtland for financial help. The Kirtland Centre was sold in August 2020 and all monies owed to Mr Kirtland have been repaid in full. We now have sufficient funds to be able to continue running the charity from our new premises which are rented from Mr Kirtland which is awaiting completion of works and dependant on Covid-19 restrictions.

It is the policy of the Society that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to between three and six month's expenditure. The trustees considers that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the Society's current activities while consideration is given to ways in which additional funds may be raised.

The Board of Trustees has assessed the major risks to which the Society is exposed, and are satisfied that the systems are in place to mitigate exposure to the major risks. The trustees regularly monitor the risk exposure of the Society and action is taken to investigate and mitigate any risks identified.

Due to the uncertainty of the Covid-19 pandemic on the clinically vulnerable and the continuing works needed on The New Kirtland Centre we will continue contacting service users, parents and carers to offer physical and mental support where needed. We plan to monitor the on-going situation regarding the pandemic and keep the charity as active as possible.

#### **Structure, governance and management**

The Society was originally registered as a charity on 4 January 1983 under registration number 286013. The Society adopted a charitable trust deed on 11 November 1982 as amended 26 June 2005.

On 10 February 2011 the Society registered as a company limited by guarantee and on 1 April 2011 the activities of the Society were transferred to the charity company under registration number 1142178. The Society has now adopted the Local Model Constitution of the Royal MENCAP Society.

The trustees are appointed by the Board of Trustees and serve for five years after which period they may put themselves forward for re-appointment.

None of the trustees has any beneficial interest in the company. All of the trustees are members of the company and guarantee to contribute £1 in the event of a winding up.

Due to Ruth Hajjiannis (Co-ordinator/Administrator) continuing deterioration of health it was agreed by all trustees that as of 28th February 2021 Ruth would step down from her position. It was further agreed by trustees that as of 1 March 2021 Jacky Hajjiannis would take over this role.

The trustees' meetings are held quarterly and at such meetings the trustees agree the Board's strategy and areas of activity for the Society, including consideration of reserves and risk management policies and performance. The Board keeps the skill requirements for the trustee body under review and in the event that a trustee permanently retires or additional new trustees are required, the Board actively recruits the new trustee by advertisement or through a dialogue with associated bodies.

The Society is a member of the Royal Mencap Society (MENCAP). The Royal Mencap Society provides helpful information on good practice, changes in the law affecting charities and acts as an authoritative lobby on behalf of the MENCAP Societies with the government regulators.


### **Auditor**



### 1 Accounting policies

#### Charity information

Tower Hamlets MENCAP Society is a private company limited by guarantee incorporated in England and Wales. The registered office is , 84 Leslie Road, London, E11 4HG.

#### 1.1 Accounting convention

The financial statements have been prepared in accordance with the Society's [governing document], the Companies Act 2006, FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the Charities SORP "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019). The Society is a Public Benefit Entity as defined by FRS 102.

The Society has taken advantage of the provisions in the SORP for charities not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the Society. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

#### 1.2 Going concern

At the time of approving the financial statements, the trustees have a reasonable expectation that the Society has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

#### 1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

#### 1.4 Incoming resources

Income is recognised when the Society is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the Society has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

#### 1.5 Resources expended

The accruals basis is applied to all expenditure.

Expenditure has been allocated according to the Statement of Recommended Practice "Accounting and Reporting by Charities" and is shown under the appropriate sub-heading. Items of expenditure which involve more than one charitable activity , are allocated appropriately between the charitable activities involved on the basis of estimates made by the charity's management.

### 1 Accounting policies

#### 1.6 Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation, net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual values over their useful lives on the following bases:

Land and buildings	nil
Equipment	20% on written down value
Fixtures and fittings	15% on written down value

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is recognised in the statement of financial activities.

#### 1.7 Impairment of fixed assets

At each reporting end date, the Society reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

#### 1.8 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

#### 1.9 Employee benefits

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the Society is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

#### 1.10 Retirement benefits

Payments to defined contribution retirement benefit schemes are charged as an expense as they fall due.

#### 1.11 Basic financial instruments

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price. Any loss arising from impairment are recognised in the profit and loss account in other administrative expenses.

#### 6 Description of charitable activities

##### Revenue

The Revenue account is for the running of The Kirtland Centre.

##### Society

Tower Hamlets MENCAP Society is a registered company limited by guarantee. We are affiliated to the Royal National MENCAP Society.

##### Gateway

Tower Hamlets Society runs a Gateway Club, which is the leisure arm of National MENCAP for people with a learning disability.
