**Objects:** 3. THE CHARITY'S OBJECTS ARE:A. **Activities:** The aim of the RAF Theatrical Association (RAFTA) is to improve theatre in the RAF.To do this, RAFTA:\*Holds an annual One Act Play Festival (improvement through competition).\*Runs a 'Project' every 2 years, putting on a show in a professional theatre.\*Runs drama courses and workshops for its members.\*Critiques shows put on by its member clubs to offer tips for improvement (adjudication).
