ADVANCING IN LIFE AND HELPING YOUNG PEOPLE BY DEVELOPING THEIR SKILLS, CAPACITIES AND CAPABILITIES TO ENABLE THEM TO PARTICIPATE IN SOCIETY AS INDEPENDENT, MATURE AND RESPONSIBLE INDIVIDUALS; II. ADVANCING AND PROMOTING EDUCATION AMONG THOSE IN NEED ANYWHERE IN THE WORLD (B) THE PREVENTION OR RELIEF OF POVERTY ANYWHERE IN THE WORLD BY PROVIDING GRANTS, ITEMS AND SERVICES TO INDIVIDUALS IN NEED AND/OR CHARITIES, OR OTHER ORGANISATIONS WORKING TO PREVENT OR RELIEVE POVERTY; (C) PREVENTION OF SICKNESS AND IMPROVEMENT OF HEALTH; (D) THE RELIEF OF FINANCIAL NEED AND SUFFERING AMONG VICTIMS OR NATURAL OR OTHER KINDS OF DISASTER IN ANY PART OF THE WORLD IN THE FORM OF MONEY (OR OTHER MEANS DEEMED SUITABLE) FOR PERSONS, BODIES, ORGANISATIONS AND/OR COUNTRIES AFFECTED; AND (E) ANY OTHER PURPOSES RECOGNISED AS CHARITABLE PURPOSES UNDER EXISTING CHARITY LAW IN ENGLAND AND WALES FROM TIME TO TIME.

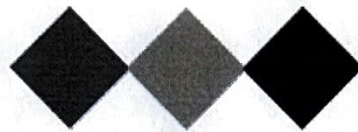

Trustee selection methods (eg. appointed by, elected by)	Appointment of Trustees i. There must be at least three Trustees. Apart from the First Trustees, every Trustee must be appointed for a term of three years by a resolution of the Trustees passed at a special meeting called under clause 15 of this deed. ii. In selecting individuals for appointment as Trustees, the Trustees must have regard to the skills, knowledge and experience needed for the effective administration of the Charity. iii. The Trustees must keep a record of the name and address and the dates of appointment, re-appointment and retirement of each Trustee. iv. The Trustees must make available to each new Trustee, on his or her first appointment: a. a copy of this deed and any amendments made to it; b. a copy of the Charity's latest report and statement of accounts. v. The First Trustees shall hold office for a period of three years. Eligibility for trusteeship i. No one shall be appointed as a Trustee: a. if he or she is under the age of 18 years; or

- b. if he or she would at once be disqualified from office under the provisions of clause 11 of this deed.
- ii. No one shall be entitled to act as a Trustee whether on appointment or on any re-appointment as Trustee until he or she has expressly acknowledged, in whatever way the Trustees decide, his or her acceptance of the office of Trustee of the Charity.

Section C

Objectives and activities

Summary of the objects of the charity set out in its governing document

- c) prevention of sickness and improvement of health;
- d) the relief of financial need and suffering among victims of natural or other kinds of disaster in any part of the world in the form of

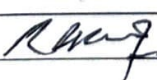
