<p>During the year, the trust delivered a wide range of activities designed to deepen public understanding of the site’s historical, cultural and environmental significance. Guided history walks and tours ran throughout the year, offering engaging learning opportunities for visitors of all ages and helping to foster greater community interest in local heritage.</p> <p>As we continued to recover from the Covid-19 pandemic, the trust continued to focus on rebuilding participation and restoring the full breadth of our activities. The return of visitors and community groups has enabled us to resume activities at pre-pandemic levels, strengthening our role as a safe, welcoming, and educational resource for the public.</p> <p>We continued to hold weddings and events on site, increasing our public reach massively. These events also provided valuable income, allowing for ongoing site maintenance and enabling us to create meaningful and accessible educational opportunities for the public.</p> <p>Feedback from visitors are participants was consistently positive, demonstrating the value of the trust’s work in promoting understanding and appreciation of the heritage site. Trustees confirm that all activities met Charity Commission guidance on public benefit.</p>


