WORKING CLOSELY WITH INDIVIDUALS TO DEVELOP THEIR SKILLS AND CONFIDENCE IT IS DESIGNED TO PREVENT A CONTINUED CYCLE OF POVERTY AND FOR THE DURATION OF EACH PROJECT PROVIDE TEMPORARY RELIEF FROM EXISTING CIRCUMSTANCES.4 THE PREVENTION AND RELIEF OF POVERTY OF INDIVIDUALS AND COMMUNITIES IN DEPRIVED AREAS AROUND THE WORLD BY WORKING WITH ESTABLISHED ORGANISATIONS AND CHARITIES AT HOME AND ABROAD AND SUPPORTING THEIR WORK TO DEVELOP SELF-SUSTAINING NUTRITIONAL, EDUCATIONAL, AND EMPOWERING ENTERPRISE PROJECTS.5 THE ADVANCEMENT OF CITIZENSHIP AND COMMUNITY DEVELOPMENT BY WORKING WITH CORPORATIONS, COMMUNITIES AND INDIVIDUALS AND MODELLING THE POSITIVE IMPACT OF ENGAGING IN DEVELOPMENT AND VOLUNTARY WORK.

**Activities:** To advance in life and help young people through the provision of projects, support and activities which develop their skills, capacities and capabilities enabling them to participate in society as mature and responsible individuals and to relieve the needs of socio-economically disadvantaged communities within the UK by working with and supporting established organisations/charities.
