PROMOTE HEALTH BY:A) TAKING PART IN ACTIVE CHARITABLE AND MEDICAL RELIEF WORK EITHER ALONE OR IN CO-OPERATION WITH ORGANISATIONS WITH SIMILAR OBJECTIVES.
