**Activities:** In coordination with the local police and the town CCTV operations we run patrols on Saturday nights in the town of Stamford, assisting those in difficulty between 9.30pm and 4am. There are further

patrols for special events such as the town's fair week in early March and during festivals etc. We also publicise our work in a variety of forums.
