Objects: THE CHARITY'S OBJECTS ("OBJECTS") ARE TO PROMOTE SOCIAL INCLUSION FOR THE PUBLIC BENEFIT AMONGST PEOPLE PARTICULARLY BUT NOT EXCLUSIVELY BETWEEN THE AGES OF 14 AND 30 YEARS LIVING IN SHROPSHIRE AND ELSEWHERE IN THE UNITED KINGDOM WHO ARE SOCIALLY EXCLUDED BY PROVIDING THEM (ACCORDING TO CHRISTIAN PRINCIPLES) WITH AN OPPORTUNITY TO DEVELOP VOCATIONAL AND PERSONAL SKILLS THROUGH TRAINING THUS ASSISTING THEM TO INTEGRATE INTO SOCIETY AND TO FULFIL SUCH OTHER PURPOSES WHICH ARE EXCLUSIVELY CHARITABLE ACCORDING TO THE LAW OF ENGLAND AND WALES AND ARE CONNECTED WITH THE CHARITABLE WORK OF THE CHARITY.FOR THE PURPOSE OF THIS CLAUSE "SOCIALLY EXCLUDED" MEANS EXCLUSION FROM SOCIETY, OR PARTS OF SOCIETY, AS A RESULT OF ONE OR MORE OF THE FOLLOWING FACTORS: UNEMPLOYMENT, FINANCIAL HARDSHIP, RACE, GENDER, POOR EDUCATIONAL OR SKILLS ATTAINMENT, DISABILITY, ETHNIC ORIGIN, OR WHO ARE WITHIN, OR HAVE EXPERIENCED, THE PUBLIC CARE OR PENAL SYSTEM.

Activities: To promote social inclusion of people between the ages of 14 and 30 years living in Shropshire and elsewhere in the UK by providing them according to Christian principles with an opportunity to develop

vocational and personal skills through training thus assisting them to integrate into society.
