The principal activities of the charity include Holding Women's Prayer /Prophetic Conference. Doing Crusades around the world Setting up Womens Refuge, Foodbank and empowering disadvantaged women Rehabilitating prostitutes, women with mental health problems. Setting up Women's mentoring and counselling services Providing the relief of needs and hardship. Setting up African Charity Shop: African food, Clothes, School to Educate Children.

#### **Donations**

The Charity made donations totalling £10,000 for Overseas Mission.

300 Children and widows supported with food stuffs and money between our partners the Anglican Church , the orphanage and Bishop Bawa ministries.

40-50 women last year received treatment through coaching and counselling with court and immigration support were given to men and women who had experienced domestic violence.

#### **Statement of directors' responsibilities**
