

The statement of financial activities includes all gains and losses in the year. All incoming resources and resources expended derive from continuing activities.

Notes forming part of the Financial Statements for the year ended 31 March 2021

1. Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

(a) Basis of accounting

The financial statements have been prepared under the historical cost convention, as modified by the inclusion of fixed asset investments at market value, and in accordance with the Companies Act 2006 and the Statement of Recommended Practice : Accounting and Reporting by Charities issued in October 2019.

(b) Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

The Small Business Grant Fund and Retail, Hospitality and Leisure Grant Fund /COVID-19 Local authority grants do not have any performance conditions attached, as they are designed to provide immediate financial support. They are therefore to be recognised immediately in income once the entity is satisfied they have the entitlement.

The income should be recognised of when the amount is received.

(c) Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to, and virtually certain to receive, the income and the amount can be quantified with reasonable accuracy. The following policies are applied to particular categories of income: Voluntary income is received by way of grants, donations and gifts and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

Donated services and facilities are included at the value to the charity where this can be quantified. The value of services provided by volunteers has not been included in these accounts.

Investment income is included when receivable.

Incoming resources from charitable trading activity are accounted for when earned.

Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

(d) Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates:

Costs of generating funds comprise the costs associated with attracting voluntary income.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examination fees and costs linked to the strategic management of the charity.

All costs are allocated between the expenditure categories of the SoFA on a basis designed to reflect the use of the resource.

(e) Fixed assets

Fixed assets (excluding investments) are stated at cost less accumulated depreciation. The costs of minor additions or those costing below £1,000 are not capitalised. Depreciation is provided at rates calculated to write off the cost of each asset over its expected useful life, which in all cases is estimated at 5 years. Impairment reviews are carried out as and when evidence comes to light that the recoverable amount of a functional fixed asset is below its net book value due to damage, obsolescence or other relevant factors.

Investments held as fixed assets are revalued at mid-market value at the balance sheet date and the gain or loss taken to the Statement of Financial Activities.

Currently all trustees are volunteers who are willing to serve as such.

Objectives and Activities

To provide quality sports and community facilities for the people of Strensall & Towthorpe and surrounding areas, to participate in sports, youth and other community activities in a safe and secure environment.

- Work with the City of York Council, Strensall with Towthorpe Parish Council, user group representatives and local residents.

- Increase the availability of the facilities both for the existing user groups and the wider community.
- Encourage increased participation of sports and other community activities, particularly amongst young people.
- Make the facilities more usable, accessible and available for extended use by altering the interior space and increasing the size of the existing committee/ meeting room.
- Make use of the facilities for festivals/events and joint activities involving partner organisations and the wider community.
- Improve the existing external facilities.
- Renewal of lease agreement with the Strensall and Towthorpe Parish Council.

Achievements and Performance

2020/21 has been a mixed year for SCYSA. COVID has been the biggest challenge, but despite COVID we have increased users, funds and sponsorship and begun the process of upgrading our sports pitches.

March 20 saw the closure of the Sports Club due to COVID and the first national lockdown. We re-opened again in September, for football, tennis, table-tennis and Ride for Life but sadly no Rainbows or Brownies. They hope to return as soon as it is safe for all their girls. Before allowing the users to return we completed comprehensive Risk Assessments and followed COVID guidelines to make the facilities safe for users.

We would like to say a big thank you to the Parish Council for helping with grass cutting over the summer months when it was difficult to secure contractors to maintain the grounds. We also look forward to the wild flowers the PC have kindly donated to SCYSA. In addition to retaining our main user groups, namely: Strensall Junior Football Club, Strensall Tennis Club, Strensall Brownies, Strensall and Flaxton Rainbows and Strensall Table Tennis Club, we have also welcomed the new Strensall Tigresses, Huntington Rovers Over 35s, Wigginton Table Tennis Club and Strensall Fitness. We continue to improve internal and external facilities and hope to see the benefits in terms of increased usage once COVID is over. Due to generous COVID grants from City of York Council, we have been able to maintain 2019 prices in 2020, however we are aware that to make us viable in the future, we will have to increase fees in 2021.

I am proud of what we have achieved in 2020 and credit it to the hard work by our Trustees and user groups. I am grateful to them all and wish them all the best for 2021.

Due to the small amount of reserves the charity uses them to pay and cover the current fees and bills, and keep reserve amount of money for unexpected maintenance payments.

The charity sold 10 advertising boards to the local companies.

Income

This financial year SCYSA has several sources for funding. The primary one are the 'The Small Business Grant Fund and Retail, Hospitality and Leisure Grant Fund' from City of York Council as an immediate financial support, secondary in the form of fees for use of the facilities, and thirdly from advertising activities. From the outset it has been our intent to provide facilities for various user groups with the intent to provide facilities for various user groups with the intent that with greater use the facility becomes self-supporting. At least in terms of covering operational expenditure.

Expenditure

During the last year, the club was closed for long time due to national covid lock downs. SCYSA has a responsibility for operational expenditure which includes, maintains like grass cutting the grass field, rent, utilities bills and safety checks, and other necessary expenditure as an insurance.

Other optional information

September was a busy month for us! Our Trustees Andy Kilvington and Paul Russell, who had been representing Strensall Tigers left SCYSA after 5 years and were replaced by Andy Parker and Tommy Hair. They quickly got to work arranging sponsorship and filling the advertising hoardings around the sports pitches. Ross Welch continues his great work for Strensall Tennis Club and missed the opportunity to run their annual Open Day in April to raise awareness, funds and membership. Matt Walton continues his efforts to secure funding for enhanced pitches, most likely in the form of a larger MUGA, as recommended by the FA in 2016.

Unfortunately, due to COVID some of the meetings and visits were unable to take place. We look forward to pursuing this venture into 2021 to improve the facilities for current and future users. We are now in the fortunate position where we have a Chair, Secretary, Treasurer plus 4 x trustees representing the different user groups = 7 in total

A further objective for next year is resurfacing the playing field (MUGA) and making the facilities comfortable for the wider community use.

The aim is to use local supplies where is reasonable to do so.
