Anyone who feels that they are not able to pay our modest subscription in a lump sum can pay weekly with prior agreement; the amount will be decided between the player and the Welfare Officer. If anyone feels that they are unable to pay subscriptions due to severe hardship, they can speak to our Welfare Officer, or one of the Trustees.


