In the year 2024 to 2025 a total of £21,456.66 was given in grants. The most significant were for choir tours to Normandy Carlisle and Exeter (£17,557.29). Details are shown in the accounts.

The charity raises funds through subscriptions, a 500 Club, running social events, such as a Quiz and Ceilidh, and providing concert services for musical events held in the Cathedral.


