Objects: THE OBJECTS OF THE CHARITY (THE "OBJECTS") ARE FOR THE PUBLIC BENEFIT:-1) TO RESTORE REPAIR MAINTAIN IMPROVE EXTEND BEAUTIFY RECONSTRUCT AND MANAGE THE CHURCH OF ALL SAINTS KINGSTON UPON THAMES (THE CHURCH) IN THE DIOCESE OF SOUTHWARK AND IN THE ROYAL BOROUGH OF KINGSTON UPON THAMES AND THE MONUMENTS FITTINGS FIXTURES STAINED GLASS FURNITURE ORNAMENTS AND CHATTELS IN THE CHURCH AND THE CHURCHYARD BELONGING TO THE CHURCH;2) TO ADVANCE THE EDUCATION OF THE PUBLIC ON THE SUBJECTS OF HISTORY AND HERITAGE IN RELATION TO ISSUES OF LOCAL AND NATIONAL IMPORTANCE IN PARTICULAR BUT NOT LIMITED TO THE HISTORY AND HERITAGE OF THE SITE AND SURROUNDINGS IN WHICH THE CHURCH IS LOCATED; AND3) TO BENEFIT THE RESIDENTS OF KINGSTON UPON THAMES AND THE NEIGHBOURHOOD, WITHOUT DISTINCTION OF SEX, SEXUAL ORIENTATION, RACE, OR OF POLITICAL, RELIGIOUS OR OTHER OPINIONS BY ASSOCIATING TOGETHER SUCH RESIDENTS AND THE LOCAL AUTHORITIES, VOLUNTARY AND OTHER ORGANISATIONS IN A COMMON EFFORT TO ADVANCE EDUCATION AND TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND/OR LEISURE TIME ACTIVITIES WITH THE OBJECTIVE OF IMPROVING THE CONDITIONS OF LIFE OF SUCH RESIDENTS.

Activities: The charity has been formed to carry forward the refurbishment and development of the historic Church of All Saints, Kingston upon Thames. As from 1 January 2013 it has taken on (by a deed of transfer) the assets, liabilities and activities of the All Saints Parish Church Kingston upon Thames Appeal Fund (registered charity 1080671).
