Children's crèche is organised every Sunday and children attend the church crèche whilst their parents are in the service. Children are taught simple Bible Teachings, do fun activities including crafts and playing games, given the opportunity to demonstrate their talents in singing and drama.

### **YOUTH MINISTRY**

We have started youth meetings for the 11- 18-year-olds every Sunday from 11 am - 11.45 am

VIC is committed to supporting agencies, charities and projects which carry out valuable and essential services to the worldwide community with the donations it receives from its members.

The commitment of the members to the vision of VIC has allowed us to maintain a vibrant, multi-cultural and healthy environment for spiritual and natural growth. We are proud of this growth but willing to improve upon to meet the objectives and goals of VIC and the divine purpose He has for this church. We are grateful unto God for how far he has brought us.

### **FINANCIAL REVIEW AND RESERVES POLICY**

The income of the charity for the year was **£129,658.82** by way of Donations, sales and gift aid. The cost of charitable activities was **£156,207.32** This was spent directly and indirectly to support the charities activities. At the end of the year there was an unfavorable net movement of funds amounting to **-£26,548.50**. At the end of the year, 31 March 2025, there was an unrestricted fund balance amounted to **£66,647.25**. The charity's policy is to retain reserves, in the form of unrestricted funds, to a level where they equate in value approximately 12 months expenditure. This should provide a reasonably secure financial base on which to plan future projects and commit to related expenditure, before external funding has been fully secured. The charity's reserves policy would be able to continue its current level of activities in the event of a significant drop in funding.

### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

#### **Governing Document**

## **REPORT OF THE TRUSTEES FOR THE PERIOD ENDED 31 MARCH 2021**

The following is an account of the activities, events and general progress of Victory in Christ Ministries in Ponders End, Enfield.

The Ministry continues to establish and develop VIC objectives of preaching the Word of God and equipping members with both spiritual and physical resources which are, at present the primary activity.

### **GENERAL INFORMATION**

The Charity was able to secure a permanent place of worship, which has a lease for five years. The premises has a hall where our meetings are held, a store room, an office upstairs and a crèche.

### **MEMBERSHIP**

Church membership in terms of numbers have been stable and has risen this year and that is due to their agreement of the beliefs of the church leaders, which is according to the Word of God and under the guidance of the Holy Spirit. We have established an event calendar so members know what events to expect in the church for the year. We have established a contact in Israel where we can buy products to sell in our book shop.

### **NURTURING THE CHURCH**

The following meetings are held weekly or bi-weekly in some cases:

- Sunday Worship Healing Service
- Tuesday Deliverance Service
- Thursday Bible Study via conference call
- Baptism Sessions all year round
- Blessing of Marriages
- New Born Baby Blessing Ceremonies
- Other special events are in addition to others Passover and Pentecost service and woman's conferences.

- Christmas Eve Service
- Holy Communion Services once a month
- New Year's Eve Service

### **CHILDREN'S MINISTRY**

Children's crèche is organized every Sunday and children attend the church crèche whilst their parents are in the service. Children are taught simple Bible Teachings, do fun activities including crafts and playing games, given the opportunity to demonstrate their talents in singing and drama. The Creche has grown to three classes.

### **YOUTH MINISTRY**

We have started youth meetings for teenagers every Sunday from 11am - 11.45am

### **SUPPORT TO OTHER CHARITABLE ORGANISATIONS & MISSIONS**

VIC is committed to supporting agencies, charities and projects which carry out valuable and essential services to the worldwide community by the donations it receives from its members. VIC also collected food & Clothes donations from church members for the local food bank and for the homeless. VIC also worked in partnership with local charitable organization in providing food and clothing to the organization to be donated to the homeless. VIC also supports a Jewish Charity – Colel Chabad. Pastor Andy and Pastor Maria have been helping out with some of Morris Cerullo World Evangelism Events in the UK.

### **TRUSTEE MEETING**

The trustees hold their annual meetings every January and will have other meeting throughout the year if needed, during which the progress of the ministry is discussed and plans to increase, train and equip its members is explored. Financial matters, assets evaluation and program of activities to involve the members and the community are also brought up in the trustee meetings and how we can have an impact with our members, in our community.

The commitment of the members to the vision of VIC has allowed us to maintain a vibrant, multi-cultural and healthy environment for spiritual and natural growth. ## **FINANCIAL REVIEW AND RESERVES POLICY**

The income of the charity for the year was **£121,296** by way of Donations. The cost of charitable activities was **£90,389**. This was spent directly and indirectly to support the charities activities. At the end of the year there was a favorable net movement of funds amounting to **£30,907**. At the end of the year, 31 March 2021, there was an unrestricted fund balance amounted to **£68,797**. The charity's policy is to retain reserves, in the form of unrestricted funds, to a level where they equate in value approximately 12 months expenditure. This should provide a reasonably secure financial base on which to plan future projects and commit to related expenditure, before external funding has been fully secured. The charity's reserves policy would be able to continue its current level of activities in the event of a significant drop in funding.

## **Charity Examiners**

It was agreed to appoint Gift Aid Services as the Independent Examiner.

### **ACCOUNTING POLICIES**

#### **Basis of Accounting**

These accounts have been prepared on the receipts and payment basis under section 42(3) of the Charities Act 1993.

#### **Funds**

Unrestricted funds are those which can be used at the Trustee's discretion. Restricted Funds are those whose purposes have been restricted by the donor.

#### **Employees**

The charity had 1 employee during the financial year. One employee is also trustee of the charity and the total salary received was £30,589. All work was undertaken by volunteers.

#### **Public Benefit**

The charity acknowledges its requirement to demonstrate clearly that it must have charitable purpose or aims that are for the public benefit. Details of how this is achieved is provided in the trustee's report. The trustees confirm that they have paid due regard to the Charity Commission guidance on public benefit before deciding what activities the charity should undertake.
