Activities: We provide a calm presence on the street making ourselves available to care, listen and support valuable people who are at risk late at night, without favour. We try to raise the Community and Church awareness of anti-social behaviour. We do this by providing a physical presence on the streets at least two Saturday nights in every month 10-00pm ---4.00am.
