**Objects:** TO PROMOTE HUMAN RIGHTS (AS SET OUT IN THE UNIVERSAL DECLARATION OF HUMAN RIGHTS, SUBSEQUENT UNITED NATIONS CONVENTIONS AND DECLARATIONS AND IN INTERNATIONAL AND REGIONAL HUMAN RIGHTS LAW) THROUGHOUT THE WORLD, AND WITH A SPECIAL FOCUS ON HUMAN RIGHTS IN THE RUSSIAN FEDERATION, BY ALL OR ANY OF THE FOLLOWING MEANS: • MONITORING ABUSES OF HUMAN RIGHTS; • OBTAINING REDRESS FOR THE VICTIMS OF HUMAN RIGHTS ABUSE; • RELIEVING NEED AMONG THE VICTIMS OF HUMAN RIGHTS ABUSE; • RESEARCH INTO HUMAN RIGHTS ISSUES; • PROVIDING TECHNICAL ADVICE TO GOVERNMENT AND OTHERS ON HUMAN RIGHTS MATTERS; • CONTRIBUTING TO THE SOUND ADMINISTRATION OF HUMAN RIGHTS LAW; • COMMENTING ON PROPOSED HUMAN RIGHTS LEGISLATION; • RAISING AWARENESS OF HUMAN RIGHTS ISSUES; • PROMOTING PUBLIC SUPPORT FOR HUMAN RIGHTS; • PROMOTING RESPECT FOR HUMAN RIGHTS AMONG INDIVIDUALS AND CORPORATIONS; • INTERNATIONAL ADVOCACY OF HUMAN RIGHTS; • ELIMINATING INFRINGEMENTS OF HUMAN RIGHTS; • PROMOTING EDUCATION AND TRAINING IN HUMAN RIGHTS.
