PURSUANT TO THIS OBJECT, THE CHARITY SHALL ESTABLISH CHURCHES IN THE UNITED KINGDOM AND IN SUCH OTHER PARTS OF THE WORLD AS THE DIRECTORS MAY FROM TIME TO TIME THINK FIT.

**Activities:** To advance the Christian religion in accordance with Christian principles in the United Kingdom and other parts of the World for the benefit of the public by the holding of prayer meetings, public celebration of religious festivals, distributing literature on the Christian faith to enlighten others about the Christian
