This year we have been successful in welcoming more families into our Church.

All are welcome to attend our regular services. At present there are between fifty and sixty parishioners on the Church Electoral Roll including adults and children Three families of whom are not resident within the parish. Two family left during the year. People normally come and go at random for various reasons. The average weekly attendance, counted during the year was still 50, There was quite a shifting during the year of membership a number of old members with their families left and the whole congregation is now full of new members made up of young families.

As well as our regular services, we enable our community to celebrate and thank God at the milestones of the journey through life, a thanks giving service takes place every 1st Sunday of the month. Through baptism we thank God for the gift of life, in marriage public vows are exchanged with God's blessing. one baptism or weddings was celebrated. Our services start on Sunday at 9am, our Tuesday service at 7pm and we hold vigils every 2nd Friday of the month which starts at 10pm.

Mission and Evangelism

Helping those in need is a demonstration of our faith. The Church donated 98 to other churches, £1,065 to Ministers Honorarium. Apart from donating to other churches and the world evangelism mission, we also regularly donate food and clothing to the food bank to help the less privileged. We **also continue to donate to Dens and residents of High View Home**. It is good that these efforts on behalf of others can be combined with opportunities for fellowship.

We now run a soup Kitchen once a month on a Saturday Morning from 11am to 1pm. Which is currently suspended.

The highest outgoing expenses was Rent for the premises which cost £7,960 per annum except for the pastors allowance which was £35,936 Per Annum inclusive of Taxes. Central office administration £8990 as above .

The net result for the year was excess expenditure over income of (£1,951) resulting in a loss It is our policy to hold the balance at the end of the year in a bank account with the bank.
