Treasurer's Report

2024 began with a welcome payment from My Child's Art, generating a profit of £302.93.

We also made a long-awaited contribution of £6,000 to the school to support the purchase of curriculum books, bringing the total PTA-funded invoices for this initiative to £10,000.

During the first half of the year, we held a successful Break the Rules Day, raising £345, and hosted our very first Easter Fair, which brought in an impressive £893. In addition, we funded the STEM Week workshops with a contribution of £1,260, funded Ukelele £839.50, and proudly supported the school football team by providing a brand-new sports kit valued at £385.

A total of £692.91 was raised from the Spring School Disco and returned to the school, along with a payment of £829.97 for the 2023 Autumn School Disco.

We hosted our first-ever Colour Run, which received fantastic feedback from both parents and pupils, along with strong interest in making it an annual event. It was a fun-filled day, though we did face a shortage of volunteers. We're hopeful that with growing enthusiasm, more parents will step forward to help in 2025. The event successfully raised £806.11.

The PTA generously funded the acquisition of brand-new book bags for the Foundation Stage costing £308.

To end the school year, we supported the year six Leavers Disco £360,10 providing disco DJ, ice cream van, refreshments, sweet cones and a balloon arch.

Starting off the new school year we were fortunate to receive a generous donation of chocolate bars, which allowed us to host a Wonky Bar event for the pupils. The event created a fantastic atmosphere and was thoroughly enjoyed by the children. Thanks to its success, we raised an impressive £697.28.

Story Stacks have now been revamped for the Foundation Stage costing £330.44.

We hosted our first Magic show which was quite effortless for the PTA team raising £768.49.

Our first-ever laser show was a huge success with the public and generated a fantastic response. While volunteer support was limited from parents, we're hopeful that the excitement and positive feedback will encourage more helpers for future events. The

show raised an impressive £2,557.99. We also worked with generous sponsors, including Sweet Pea and Zoe Holder, who each contributed £250 towards the event.

Our yearly Christmas event was a huge hit as always raising a total of £4476.36. (Raffle £982.05 – Santas Grotto £231.89 – Fair £1,813.38). Not forgetting Secret Santa raising £1449.04.

The Christmas spirit was truly alive when we received two generous donations—£500 from Storage Systems and £200 from PepsiCo.

Our yearly income from the school lottery (£1597) and Easy Fundraising (£79.18) continued to bring in a regular income.

The PTA reallocated the previously ring fenced £18,000 Trim Track fund to better align with the school's evolving needs. As part of this, we are proud to have contributed £13,840 towards the transformation of the former music room into a brand-new library space. This investment has supported the renovation of the library environment, creating a valuable resource for all pupils. The remaining funds were agreed to support additional initiatives, such as playground equipment to be paid out in 2025.

In 2024, the total gross income was £29,496.22, while expenses amounted to £45,267.71, resulting in a net deficit of £15,771.49.

Purpose of Audit

The purpose of this audit was to review the financial records of the PTA for the above period to ensure that:

All income and expenditure was properly recorded.

Bank balances match the treasurer's records.

Expenditures were supported by appropriate documentation and authorised according to PTA procedures.

Funds were used to support the objectives of the PTA.

Documents Reviewed

Bank statements (all months within the period).

Any Treasurer's reports presented at PTA meetings.

Receipts, invoices, and reimbursement forms.

Deposit slips and fundraising tally sheets.

Findings

1. Bank Reconciliation

The closing balance as of 31/12/2024 was £20,260.55, which matches the treasurer's records.

2. Income

All deposits recorded were traceable to PTA events, fundraising activities, or donations.

Sample checks confirmed that income recorded matched bank deposits.

During the audit period, there was one instance where funds from a school-led GoFundMe campaign for the Forest School relay were mistakenly directed into the PTA bank account.

This occurred because the fundraiser was set up using the PTA's charity status, which automatically linked the income stream to the PTA account. As a result, the PTA received funds that were not raised on its behalf.

- **Evidence:** Confirmation of this arrangement is documented in the correspondence between the PTA and the school (see email excerpt provided).
- **Resolution:** The school issued an invoice to the PTA for repayment of the funds, which was duly actioned. Both the GoFundMe transfer and subsequent repayment are recorded in the PTA's accounts with supporting documentation.

This was reviewed as a genuine administrative error rather than a misuse of PTA funds. Appropriate corrective action was taken, and no financial loss to the PTA or school was identified.

3. Expenditure

All expenses were supported by receipts/invoices.

Payments were approved according to PTA procedures and aligned with the aims of the association.

4. Record-Keeping

The treasurer's report that was presented to the PTA was consistent with bank records.

No unexplained discrepancies were noted.

Recommendation

It is recommended that, in future, the school and PTA establish a clear process for setting up fundraising pages to avoid similar confusion, and that the PTA is notified in advance if its bank account is to be used for external collections.

Conclusion

Based on the review of available records, the financial accounts of the Sketchley Hill Primary School Association PTA for the period 01/01/2024 - 31/12/2024 are a true and accurate reflection of the association's financial activities.
