CHRISTIAN OUTREACH IN THE ALPS ANNUAL REPORT 1 MAY 2020 – 30 APRIL 2021

CORA's mission statement is 'To share the love, grace and truth of Jesus Christ with English-speakers in the Alps'.

Due to Covid-19 we were not able to have any chaplains in Verbier for the whole year. This sadly meant that we were unable to hold our normal Sunday services during the summer music festival, or any of our regular Sunday evening services throughout the winter season.

However, we continued with our virtual services, using Zoom, that we had started at the end of last winter season. We ran nine virtual services between 3 May and 8 Nov 2020, and twenty between 13 December 2020 and 25 April 2021 at weekly intervals except over Christmas.

The virtual services were very well attended, with congregations regularly of over 50. This was more than our normal live congregations in Verbier, as ESC friends joined us from all over the world. We received much positive feedback on the services, both for their spiritual content and also for the very high standard of music they included. This represented rather a remarkable silver lining to the pandemic, which in so many other ways caused huge disruption.

During the year we updated our objectives and launched a mission action plan to explore ways of implementing them. This will continue in the year starting 1 May 2021.

As always, we are open to new opportunities for encouraging and supporting Christian Outreach in the Alps.
