Armenian Community Council of the UK is a registered charity number 1147935. The Charity's governing document is its latest amended Constitution dated 04/11/2016. There has been no change of Trustees during this period which has now been recorded with the Charity Commission. Council elections are held within 4 to 5 years in rotation. Registered Members of the Community who fulfil the stated (Clause 44, of ACC UK's Constitution) conditions are entitled to stand as candidates for election to the Council.

## Objectives & Activities

The Council represents and acts for the Armenian community in the United Kingdom. Attends to the affairs of the community including social, cultural, educational, and financial, and pursues, for the public benefit, its objects as set forth in its governing document with the aim to improve the community's moral, religious, educational, intellectual, social development and health and well-being. The further exclusive Charitable objects of the trust are as follows:

To advance such charitable purposes for the public benefit in particular but not limited to:

- (a) Promoting the arts, culture and heritage of, in particular that of, the Armenian people and of Armenia.
- (b) Advancing education in particular in the teaching and study of the history, language, heritage and culture of the Armenian people and the Doctrine of the Armenian Apostolic Church.
- (c) Promoting racial harmony in particular by promoting good relations with people by advancing cultural, religious and educational exchanges for the benefit of the public.
- (d) To support or further the charitable work of other registered charities in England and Wales.

## Achievements and Performance

During the financial year ended 31 December 2021, the donations and annual contributions decreased due to the Pandemic curbing the participation of the community members. However, a special appeal by the charity to the community for emergency humanitarian assistance has led to the receipt of higher donations to be used by the trustees on community members in affected parts of Armenia and Lebanon.

### Financial Review

The charity's primary source of income has derived from the donations and annual contributions from the community members. During the year, the charity's cash funds increased through its emergency appeal for humanitarian aid for the affected communities in Lebanon and Armenia. The charity continues to ensure it has the financial resources to maintain its objectives.

### Statement of Trustees' Responsibilities

The trustees are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with the applicable law and United Kingdom Standards (United Kingdom Generally Accepted Accounting Practice). The applicable law for charities in England and Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of the charity and of the incoming resources and the application of resources of the charity for that year. In preparing these financial statements, the trustees are required to:

5. Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.


