THE SEVEN PRINCIPLES OF SPIRITUALISM, ARE:- 1) THE FATHERHOOD OF GOD. 2)THE BROTHERHOOD OF MAN. 3)COMMUNION OF SPIRITS AND THE MINISTRY OF ANGELS. 4)THE CONTINUOUS EXISTENCE OF THE HUMAN SOUL. 5)PERSONAL RESPONSIBILITY. 6)COMPENSATION AND RETRIBUTION HEREAFTER FOR ALL THE GOOD AND EVIL DEEDS DONE ON EARTH. 7)ETERNAL PROGRESS OPEN TO EVERY HUMAN SOUL. 2.3 TO SERVE THE PUBLIC BY PROMOTION OF THE STUDY AND PRACTICE OF THE ART AND SCIENCE OF SPIRITUAL HEALING, ADMINISTERED THROUGH PRAYER, OR BY THE LAYING-ON OF HANDS, FOR THE HEALING OF SPIRIT, MIND AND BODY, AND INCLUDING SUCH ALLIED COMPLEMENTARY THERAPIES AS HAVE A SPIRITUAL BASIS. 2.4 THAT THE CENTRE BE USED FROM TIME TO TIME FOR OTHER EVENTS DEEMED TO BE COMPATIBLE WITH 2.2 ABOVE AND AGREED TO BY THE CURRENT COMMITTEE.
