STRUCTURE, GOVERNANCE AND MANAGEMENT

Organisational status

The Mission, Nelson ("the charity") was established on 26th July 2012 and is registered with the Charity Commissioners (registration number 1148315). The charity is governed by a trust deed dated 16th April 2012.

Organisational structure

The Board currently consists of the trustees and is responsible for key policy decisions and the effective governance of the organisation overall. The trustees take care of the day to day running and legal requirements of the charity and the Board meets on a regular basis.

Recruitment and appointment of new trustees

Trustees are appointed to reflect the skills required to support the Board and its range of activities. The Trustees themselves appoint new Trustees to the Board, with agreement from the Spiritual Leadership and provide appointees with a full orientation of the services provided the decision-making processes of the charity and the roles and responsibilities of a trustee, including their legal obligations under applicable laws.

Risk management

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to ensure that regular reports are produced and that necessary steps can be taken to address any issues arising.

OBJECTIVES AND ACTIVITIES

The objectives of the charity are for the benefit of the public and are to advance the Christian faith in accordance with the statement of beliefs in such ways and in such parts of the United Kingdom or the World as the trustees from time to time may think fit and to fulfil such other purposes which are exclusively charitable according to the law of England and Wales and are connected with the charitable work of the church.

Public benefit

In setting out the charity's objectives and planning of activities the trustees have given careful consideration to the Charity Commission's general guidance and section 17(5) of the Charities Act 2011. The trustees are confident that the charity offers services of real and practical use to the local population and therefore complies with the responsibility placed on all charities under the Charities Act 2011 to demonstrate a public benefit.

ACHIEVEMENTS AND PERFORMANCE

We have ensured that provision is made for the following —worship and prayer, pastoral and associated care for anyone who needs it and missionary and outreach work. The church has continued to meet for collective worship with Sunday morning services. The morning service continues to be streamed regularly online for church members and the wider public who are unable to attend in person. Attendance at services has been increasing steadily.

Life Groups have taken place for those who wish to discuss and develop their Christian faith. The Tots Group continued to meet in the Church on Mondays and Thursdays each week in term-time and continues to be well attended by both church members and children and parents or carers from the local community. On Wednesday each week in term-time, Mission Cafe provides very reasonably priced food and fellowship at lunchtime for anyone wishing to attend.

A small group within the church has continued to provide support to asylum seekers and refugees in the Pendle area. The particular focus is on asylum seekers, who are welcomed as individuals and provided with spiritual and practical support according to their needs. Several asylum seekers have become regular attenders of the church and a few have played an active role in the life of the fellowship.

ACHIEVEMENTS AND PERFORMANCE (CONTINUED)

The church also has a group, 'Mission Together', who are particularly conscious of the needs of those members of the church who are alone or isolated for any reason. The Together Team has arranged various events for members and attenders of the church throughout the year.

The church has supported missionary work, both in financial and material ways and continues to support individuals and organisations both in the UK and overseas.

A youth group, 'Ignite', has continued to meet at The Mission building on a Friday evening on a monthly basis. This group provides physical activities and spiritual input to children from both church families and the local community. This group caters for school years 6 to 13 and is run exclusively by volunteer members of the church.

As regards administrative matters, the church continues to run a Safeguarding Policy and Procedure, and has a Safeguarding Team in place to ensure this policy and procedure is effectively enforced and children and vulnerable people are properly protected. The Church has implemented the requirements of the General Data Protection Regulation.

The full-time paid Pastor of The Mission left his role in early 2024. The church membership, Trustees and Leadership have not yet made a decision whether and how to seek a replacement for this role and discussions regarding this are ongoing. The Church continues to be run by its Trustees for legal and charity regulations and by its Spiritual Leadership for Pastoral Care.

The Trustees, alongside the Spiritual Leaders have implemented a Pastoral Care Policy.

Future plans

Future plans will be driven by the needs of the church and wider community. Events and meetings will be held in person and using video conferencing / messaging tools where appropriate.

Reserves policy

At 31st March 2025 total reserves carried forward stand at £158,036 (2024: £136,918). All of these funds are unrestricted and can be used by the charity as the trustees see fit.

The trustees believe the net asset position is sufficient for the future needs of the charity. However, these levels are reviewed annually.

Related parties

There were no related parties during the financial year (2024: £Nil).



1. ACCOUNTING POLICIES

Accounting convention

The accounts (financial statements) have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011 and UK Generally Accepted Practice.

Cash flow

The charity is exempt from the requirement to prepare a cash flow statement as it qualifies as a small entity.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Income from donations, legacies, fundraising and similar incoming resources are included in the year in which they are receivable.

Any income received for specific purpose is accounted for as restricted funds when receivable.

Resources expended

Expenditure is accounted for on an accruals basis (inclusive of attributable value added tax which cannot be recovered) and has been classified under the principal categories related to the cost.

Costs allocated to activities in the furtherance of the charity's objects are those directly associated with achieving the charity's goals. Governance costs are those incurred in connection with the management of the charity's assets, organisational administration and compliance with constitutional and statutory requirements. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in the furtherance of the general activities of the charity. Surplus funds can be allocated to restricted projects if the trustees believe they are required.

Restricted funds are funds subject to specific restriction imposed by the donors for the purpose of any appeal in which the funds are raised and can only be used for particular purpose within the objects of the charity.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

The group within the Church known as "Mission Ark" has continued to welcome asylum seekers and refugees coming into the Pendle Area. The particular focus is on asylum seekers, who are welcomed as individuals and provided with welcome packs of necessary items and with clothing given by members of the Church or purchased by the group. This ministry continues to serve asylum seekers located in our area in a variety of ways. Several asylum seekers have become regular attenders of the church and play an active role in the life of the fellowship.

The Church also has a group, "Mission Together", who are particularly conscious of the needs of those members of the church who are alone or isolated for any reason. The Together Team has arranged various events for members and attenders of the Church throughout the year.

The Church has supported missionary work, both in financial and material ways and continues to support individuals and organisations both in the UK and overseas.

The Church's youth group, "Ignite", meets monthly at The Mission on a Friday evening during school term time. This group provides physical activities and spiritual input to children from both church families and the local community. This group caters for school years 6 to 13 and is run exclusively by volunteer members of the church.

As regards administrative matters, the Church continues to run a Safeguarding Policy and Procedure and have a safeguarding team in place to ensure this policy and procedure is effectively enforced and children and vulnerable people are properly protected. Also, the Church has implemented the requirements of the General Data Protection Regulation.

The full-time paid Pastor of The Mission left his role in early 2024. The church membership, Trustees and Leadership have not yet made a decision whether and how to seek a replacement for this role and discussions regarding this are ongoing. The Church continues to be run by its Trustees for legal and charity regulations and by its Spiritual Leadership for Pastoral Care.

Future plans

Future plans will be driven by the needs of the church and wider community. Events and meetings will be held in person and using video conferencing / messaging tools where appropriate.

Reserves policy

At 31st March 2024 total reserves carried forward stand at £136,918 (2023: £157,303). All of these funds are unrestricted and can be used by the charity as the trustees see fit.

The Trustees believe the net asset position is sufficient for the future needs of the charity. However, these levels are reviewed annually.

Related parties

There were no related parties during the financial year (2023: £Nil).





Accounting convention

STRUCTURE, GOVERNANCE AND MANAGEMENT

Organisational status

The Mission, Nelson ("the charity") was established on 26th July 2012 and is registered with the Charity Commissioners (registration number 1148315). The charity is governed by a trust deed dated 16th April 2012.

Organisational structure

The Board currently consists of the trustees and is responsible for key policy decisions and the effective governance of the organisation overall. The trustees take care of the day to day running and legal requirements of the charity and the Board meets on a regular basis.

Recruitment and appointment of new trustees

Trustees are appointed to reflect the skills required to support the Board and its range of activities. The trustees themselves appoint new trustees to the Board and provide appointees with a full orientation on the services provided, the decision-making processes of the charity and the roles and responsibilities of a trustee, including their legal obligations under applicable laws.

Risk management

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to ensure that regular reports are produced and that necessary steps can be taken to address any issues arising. As Coronavirus restrictions continued throughout 2020-21, all church activities continued to be held online or paused due to the restrictions in place and risks associated with meeting as a church.

OBJECTIVES AND ACTIVITIES

The objectives of the charity are for the benefit of the public and are to advance the Christian faith in accordance with the statement of beliefs in such ways and in such parts of the United Kingdom or the World as the trustees from time to time may think fit and to fulfil such other purposes which are exclusively charitable according to the law of England and Wales and are connected with the charitable work of the church.

Public benefit

In setting out the charity's objectives and planning of activities the trustees have given careful consideration to the Charity Commission's general guidance and section 17(5) of the Charities Act 2011. The trustees are confident that the charity offers services of real and practical use to the local population and therefore complies with the responsibility placed on all charities under the Charities Act 2011 to demonstrate a public benefit.

ACHIEVEMENTS AND PERFORMANCE

We have ensured that provision is made for the following —worship and prayer, pastoral and associated care for anyone who needs it and missionary and outreach work. The church continued to meet exclusively online throughout COVID restrictions to comply with recommendations and minimise the risk of infection. Online services were held weekly with a good number of our members attending either live or viewing the service later. A special Carol Service was held outdoors in December 2021 in co-operation with other churches in the area. Morning and evening services have been held on each Sunday throughout the year when COVID restrictions allowed. This commenced with mid-week prayer meetings from mid May. Services resumed 'in person' with social distancing at the end of June 2021 with pre-booking required to ensure social distancing could be maintained. Measures were lifted in line with government guidelines at the end of July 2021, permitting the church to meet without restrictions. Similar to many other churches, numbers attending morning services were significantly reduced following the easing of COVID restrictions. Services have continued to be streamed live for members who are unable or uncomfortable to attend in person services. Life Groups have taken place online for those who wish to discuss and develop their Christian faith and some of these have returned to in person meeting as easing of COVID restrictions permitted. The Mums and Tots Group resumed meeting in the Church on Mondays and Thursdays each week during term time as COVID restrictions eased. On Wednesday each week, Mission Cafe, staffed by volunteers, provides very reasonably priced food and fellowship at lunchtime for anyone wishing to attend. Mission Café resumed at the end of July 2021 serving a more basic menu than prior to COVID lockdowns.

ACHIEVEMENTS AND PERFORMANCE (CONTINUED)

The group within the Church known as "Mission Ark" has continued to welcome asylum seekers and refugees coming into the Pendle Area. The particular focus is on asylum seekers, who are welcomed as individuals and provided with welcome packs of necessary items and with clothing given by members of the Church or purchased by the group. This ministry continues to serve asylum seekers located in our area in a variety of ways. This included hosting a 'Nowruz' (Iranian New Year) celebration at the church building on March 26th.

The Church also has a group, "Mission Together", who are particularly conscious of the needs of those members of the church who are alone or isolated for any reason. The Church has supported missionary work, both in financial and material ways, in particular the work of the Bethany Project in Tanzania. The work of individual missionaries, most notably in India, was also supported.

A youth group, "Ignite", was re-established in September. Meeting at The Mission building on a Friday evening during school term time, this group provides physical activities and spiritual input to children from both church families and the local community. This group caters for school years 6 to 13 and is run exclusively by volunteer members of the church.

At the end of March, the church hosted an event to celebrate 'Nowruz' which marks the Iranian New Year. The event was an opportunity for asylum seekers to have space to celebrate their New Year and for the church to join with their celebration.

As regards administrative matters, the Church continues to run a Safeguarding Policy and Procedure and have a Safeguarding team in place to ensure this policy and procedure is effectively enforced and children and vulnerable people are properly protected. Also, the Church has implemented the requirements of the General Data Protection Regulation.

There have been no changes to church personnel in the past 12 months. Pastor Ed McGirr and his wife Anita have settled in well in Nelson, and Ed has settled in well to the role of Pastor at The Mission.

Future plans

Future plans will be driven by the needs of the church and wider community. Events and meetings will be held in person and using video conferencing / messaging tools unless circumstances mean restrictions have to be reintroduced on public gatherings again.

Reserves policy

At 31st March 2022 total reserves carried forward stand at £146,186 (2021: £161,204). All of these funds are unrestricted and can be used by the charity as the trustees see fit.

The trustees believe the net asset position is sufficient for the future needs of the charity. However, these levels are to be reviewed annually.

Related parties

There were no related parties during the Financial Year.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Organisational status

The Mission, Nelson ("the charity") was established on 26th July 2012 and is registered with the Charity Commissioners (registration number 1148315). The charity is governed by a trust deed dated 16th April 2012.

Organisational structure

The Board currently consists of the trustees and is responsible for key policy decisions and the effective governance of the organisation overall. The trustees take care of the day to day running and legal requirements of the charity and the Board meets on a regular basis.

Recruitment and appointment of new trustees

Trustees are appointed to reflect the skills required to support the Board and its range of activities. The trustees themselves appoint new trustees to the Board and provide appointees with a full orientation on the services provided, the decision-making processes of the charity and the roles and responsibilities of a trustee, including their legal obligations under applicable laws.

Risk management

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to ensure that regular reports are produced and that necessary steps can be taken to address any issues arising. As Coronavirus restrictions continued throughout 2020-21, all church activities continued to be held online or paused due to the restrictions in place and risks associated with meeting as a church.

OBJECTIVES AND ACTIVITIES

The objectives of the charity are for the benefit of the public and are to advance the Christian faith in accordance with the statement of beliefs in such ways and in such parts of the United Kingdom or the World as the trustees from time to time may think fit and to fulfil such other purposes which are exclusively charitable according to the law of England and Wales and are connected with the charitable work of the church.

Public benefit

In setting out the charity's objectives and planning of activities the trustees have given careful consideration to the Charity Commission's general guidance and section 17(5) of the Charities Act 2011. The trustees are confident that the charity offers services of real and practical use to the local population and therefore complies with the responsibility placed on all charities under the Charities Act 2011 to demonstrate a public benefit.

ACHIEVEMENTS AND PERFORMANCE

We have ensured that provision is made for the following - worship and prayer, provision of pastoral and associated care for anyone who needs it, and missionary and outreach work. Due to the Coronavirus pandemic and associated risks and restrictions, morning services have been held in the building, without a congregation on each Sunday throughout the year and livestreamed on social media platforms. These morning services have proved popular, with a number of non-regular churchgoers watching. Sunday evening services have been on hold during this financial year. Meetings for young people have not been held and most weekly Life Groups have taken place online for those who wish to discuss and develop their Christian faith. Due to the impact of Coronavirus restrictions, both Mums and Tots and Mission Café, along with all regular meetings at the Church, continue to be placed on hold until restrictions permit and appropriate safety measures are in place.

The group known as Mission Ark has continued to welcome asylum seekers and refugees coming into the Pendle Area. The particular focus is on asylum seekers who are welcomed as individuals and provided with welcome packs of necessary items and with clothing given by members of the Church or purchased by the group. Coronavirus restrictions have meant face to face activities with asylum seekers have been limited to providing welcome packs and support which could be managed safely based on the current restrictions at the time.

The Church has supported missionary work, both in financial and material ways, in particular the work of individual missionaries locally and in India as well as the Bethany Project in Tanzania.

ACHIEVEMENTS AND PERFORMANCE (CONTINUED)

The youth group, Ignite, has not met in person due to coronavirus restrictions. Later in the year, regular activity packs were provided to the group to enable them to meet online during restrictions. These packs provide physical activities and spiritual input to children from both Church families and the local community. This group caters for school years 6 to 13 (ages 10-18) and is run exclusively by volunteer members of the Church.

The Church continues to run a Safeguarding Policy and Procedure, and have a Safeguarding team in place to ensure this policy and procedure is effectively enforced and children and vulnerable people are properly protected. Also, the Church has implemented the requirements of the General Data Protection Regulation.

There have been no changes to Church personnel in the past 12 months. Pastor Ed McGirr continues to serve as Pastor of The Mission, supported by his wife Anita. Ed and Anita ably served the Church while we have been unable to meet in person, with Ed routinely leading Church services online.

Future plans

Future plans continue to be driven by the restrictions imposed as a result of the Coronavirus pandemic. Church services have moved to fully online and the Church will continue to provide resources and equipment to ensure this can continue safely and effectively. Events and meetings will to be held using video conferencing / messaging tools until such time as public gatherings are permitted by regulations and can be safely held with the appropriate hygiene and infection controls in place.

Reserves policy

At 31st March 2021 total reserves carried forward stand at £161,204 (2020: £161,908). All of these funds are unrestricted and can be used by the charity as the trustees see fit.

The trustees believe the net asset position is sufficient for the future needs of the charity. However, these levels are to be reviewed annually.

Related parties

There were no related parties during the Financial Year.

1. ACCOUNTING POLICIES

Accounting convention

The accounts (financial statements) have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16th July 2014 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1st January 2015.

Cash flow

The charity is exempt from the requirement to prepare a cash flow statement as it qualifies as a small entity.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Income from donations, legacies, fundraising and similar incoming resources are included in the year in which they are receivable.

Any income received for specific purpose is accounted for as restricted funds when receivable.

Resources expended

Expenditure is accounted for on an accruals basis (inclusive of attributable value added tax which cannot be recovered) and has been classified under the principal categories related to the cost.

Costs allocated to activities in the furtherance of the charity's objects are those directly associated with achieving the charity's goals. Governance costs are those incurred in connection with the management of the charity's assets, organisational administration and compliance with constitutional and statutory requirements. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in the furtherance of the general activities of the charity. Surplus funds can be allocated to restricted projects if the trustees believe they are required.

Restricted funds are funds subject to specific restriction imposed by the donors for the purpose of any appeal in which the funds are raised and can only be used for particular purpose within the objects of the charity.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.
