### REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 JULY 2025

The trustees present their report with the financial statements of the charity for the year ended 31 July 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

#### OBJECTIVES AND ACTIVITIES

##### Objectives and aims

Charity for Kids' objectives are to promote and further the care and relief of children, who are still in full time education, who have a terminal illness or who are suffering from a life-threatening medical condition and during reasonable wishes of such children.

To also relieve the needs of children with a severe disability or impairment or any disability that immobilises a child by providing such facilities, equipment and services that are over and above those which the local authorities provide.

The trustees confirm that they have referred to the guidance contained in the Charity Commission for general guidance on public benefit when reviewing the Charity's aims and objectives.

Charity for kids was founded by Paul Harris in 2011, and the Charity continue to provide for children in the local community, fulfilling the aspirations of Paul, to raise funds to make a difference to the lives of poorly children locally, giving back to those in need in our community.

##### Volunteers

Charity for Kids continues to have approximately 10 regular volunteers and actively encourage new members to join through fund raising events, our social media pages i.e Facebook, Twitter and via our website and we would welcome new volunteers in 2026

None of the volunteers or trustees receive a salary.

#### ACHIEVEMENTS AND PERFORMANCE

##### Charitable activities

In the past 12 months Charity for Kids has continued to help a range of children in the Hastings & Rother area.

Our applications approach continues to be the same, with monies spent on children, both individually and most recently via community projects we were involved in, which will benefit many children and not just individuals.

Monies spent in total on both Grants applications and projects together totaling £27,682. £10,000 of this was specifically designated to the Bexhill Beach Garden project, which will enable wheelchair access for many children and adults alike. This was a very big project which Charity for kids were proud to have been a part of.

On an individual basis, we were able to assist £17,682 in Grants, helping to meet individual requests, working with specialist schools and hospitals in the area.

The team have been able to host events to keep our brand strong in our area and it was great to see children we had helped in the past pop by and say hello.

##### Fundraising activities

As i write this report, we are discussing a number of potential projects we would like to do in the area and we are encouraging community/companies, to come forward and see how they can support CFK in the up and coming twelve months. We hope this will enable us to continue serving the community.

#### FINANCIAL REVIEW

##### Principal funding sources

The principal source of funding for the year has come from donations and fundraising activities totalling £21,522.

##### Reserves policy

#### 1. STATUTORY INFORMATION

Charity for Kids is an unincorporated charity, registered in England & Wales. The charity's registered number and registered office address can be found in the Report of the Trustees.

#### 2. ACCOUNTING POLICIES

##### Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

In preparing the financial statements, the trustees are required to make an assessment of the ability of the charity to continue as a going concern. The trustees have prepared a cash flow forecast and budgets for the charity.

On the basis of these forecasts and the fact that the charity has substantial net current assets and net assets, the trustees are confident that the charity has adequate resources to continue in operational existence and to meet its liabilities as they fall due for the foreseeable future. As a result of the above, the trustees have concluded that it remains appropriate to adopt a going concern basis of preparation in these financial statements.

##### Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably. Income is only recognised when any performance objectives have been met.

##### Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

##### Taxation

The charity is exempt from tax on its charitable activities.

##### Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

In the past 12 months Charity for Kids has continued attending several events to publicise the charity including two local Christmas events. This enabled us to market the charity to the local community which continues to help a range of children in the Hastings & Rother area.

Fundraising plays a key part of the charity and throughout the year has seen a wide range of support from local businesses and individuals that has enabled us to support applications for specialist equipment not available from the NHS, including buggies, adaptive clothing and medical equipment.

### REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 JULY 2022

The trustees present their report with the financial statements of the charity for the year ended 31 July 2022. To also relieve the needs of children with a severe disability or impairment or any disability that immobilises a child by providing such facilities, equipment and services that are over and above those which the local authorities provide.

The trustees confirm that they have referred to the guidance contained in the Charity Commission general guidance on public benefit when reviewing the Charity's aims and objectives.

Charity for Kids was set up by Paul Harris, Paul was stuck in a rut of drinking, smoking along with a poor diet, to get fit Paul entered the Hastings Half Marathon and decided to raise funds to make a difference to the lives of poorly children throughout the local community.

##### Volunteers

Charity for Kids continues to have 10 regular volunteers and actively encourage new members to join through fund raising events, our social media pages i.e. Facebook, Twitter and via our own website. We continue to encourage new members through our regular correspondence letters which go out to local businesses and supporters.

None of the volunteers or trustees receive a salary.

#### ACHIEVEMENT AND PERFORMANCE

##### Charitable activities

In the past 12 months Charity for Kids has continued to help a range of children in the Hastings & Rother area.

These include children with conditions such as ADHD, Autism, Spina Bifida and Cerebral Palsy.

We were delighted to announce our 10th year anniversary, however disappointed that we were unable to celebrate. I am sure we will do this when we are able to.

Our founder and chief executive Paul Harris resigned from the charity after 10 years' service. We are grateful to him for his support. The remaining three trustees continue to provide the direction and support of the charity.

We were blessed in the last 12 months to receive support from a legacy of a gentleman in St Leonards. Being a beneficiary of his estate will only strengthen the support the charity can provide in 2022/23.

##### Fundraising activities

As a team of volunteers times have been difficult to fundraise due to the pandemic and also the financial world impacting the UK. We have been lucky to receive support from local businesses and community groups, who have all donated to CFK to help us keep up the demand for our services.

#### FINANCIAL REVIEW
