Summary of the purposes of the charity as set out in its governing document	Para 1.17	<p>The charity's objects are</p> <p>To advance in life and help young people in Africa through supporting projects in Africa that:</p> <p>(a) develop young people's skills, capacities and capabilities to enable them to participate in society as independent, mature and responsible individuals; making them more employable and increase their standard of living in the future.</p> <p>(b) advance education through sponsorship, free education, after-school classes, training programs and the offering of resources to ill-equipped schools.</p> <p>(c) Relieve poverty or financial hardship in Africa by providing or assisting in the provision of education, training, healthcare projects and all the necessary support designed to enable individuals to generate a sustainable income and be self-sufficient.</p>
Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	<p>All our charitable activity for this financial year has focused on the provision of education and support for some of the poorest most disadvantaged families in the Moshono community in Northern Tanzania.</p> <p>We continue to sponsor the education of 83 children in Tanzania, children who would otherwise not be in school, let alone receiving a good quality education. We provide the funds to cover their school fees, uniforms, shoes, sportswear, a school bag and stationery. We also ensure the school fees paid include two meals a day for all the children.</p> <p>As at October 2024 we have 14 children at Primary School and 46 in secondary school. 11 in Yr 5 and 2 in Yr 6 , 3 on vocational courses,</p>

		<p>and 7 have completed their sponsorship through Rise Africa.</p> <p>For secondary education we continue to use a boarding school option, the Renea School, which has one for boys and one for girls and they are boarding schools. This ensures the children are able to really focus on their education and maximise the opportunity we are offering them. Penina visits the school on a regular and we remain extremely impressed by the school and all it does for the children. The children love Renea and all say they prefer school to home !!</p> <p>All the students receive full payment for their school fees, which we pay directly to the schools, we then provide all the children with new shoes, bags and stationery twice a year. We provide all the secondary school students with boarding school needs, textbooks, dictionaries and calculators.</p> <p>Renea School now has the 40 computers and the dedicated computer studies classroom for the use of the boys and the girls. We also aim to provide those students that go to university with a laptop computer.</p> <p>We have continued to provide families with food essentials twice a year, once in June and once in December, these food parcels usually contain rice, maize flour, cooking oil, salt and soap.</p> <p>The Girl Project - We continue to help all 45 Rise Africa girls with sanitary pads and new underwear throughout the year.</p>

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	<p>We have supported the education and development of 76 children in 2023/4, 60 in private schools, 13 in Government Yr 5 and 6 and on 3 vocational courses. 7 have now completed their sponsorship. We expect our first students in University in 2024/25.</p> <p>In addition to school fees, children receive uniform, stationary, school bags, shoes, sports kit and 2 or 3 meals a day at school.</p> <p>The Feeding Program has continued to be essential in helping children and their families during the school holidays. The families remain in need of our help and for some it's become an issue as to where they are going to live and we are reviewing how we might be able to help. We were again able to donate food on 2 separate occasions during the year as it remains a real struggle to earn money to feed themselves during the holiday periods. Each food parcel costs circa £25</p> <p>The Girl Project - Young girls who do not have money to buy sanitary pads often use old cloth or anything they can find, but these methods are unhygienic and often lead to infections. We have therefore helped these girls with sanitary pads throughout the year costing £560 a year. Through this project we have also supplied all the girls with new underwear, costing a total of £350 for all 45 girls.</p> <p>School fees have increased to £750 a year for secondary students and around £600 for primary students. Most sponsors have increased their donations to cover this increase. And the strengthen pound has assisted limiting the need for additional sponsorship.</p>

Financial Review

Review of the charity's financial position at the end of the period	Para 1.21	On 31 October 2023, the balance on the bank was £54,622 a decrease of £5255 in the year. This was due to the computer project funds being included at the year end 2022/23. However there is an outstanding gift aid claim and with this included for the year 2023/24 Rise Africa had a surplus of £3439.
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	All of this has been allocated to pay for the year 2024/245 school fees, stationary, uniforms etc. The schools have increased the school fees for 2024/25 and most of our sponsors have increased their contributions. However, with the improved exchange rates the impact of the fee increases has been minimal. We will use extra funds to cover the rise in costs and the additional rise in the costs of all the school supplies we provide. Further donations throughout the year will be used to support community projects. The charity is also run on the basis that we keep 12 months of costs in the bank to ensure we have time to react should circumstances or our fund-raising change significantly.
