Activities: Advance religion in Catholic tradition of CofE churches of wider Anglican communion. Promote religious/charitable work of CofE worldwide including training & support of lay/ordained ministers. Provision of facilities for public worship. Encourage devotion to blessed sacrament & making grants to support Eucharistic worship/teaching.
