**Objects:** THE CHARITY'S OBJECTS ARE SPECIFICALLY RESTRICTED TO THE FOLLOWING: TO ADVANCE THE EDUCATION OF CHILDREN AND YOUNG PEOPLE (AGED 4 TO 18), AS WELL AS ADULTS, IN THE SUBJECT OF PRE-MODERN WORLD HISTORY AND THE CONTACT BETWEEN CIVILIZATIONS BY (BUT NOT BY WAY OF LIMITATION) THE FOLLOWING MEANS: A) TO PUBLISH ACADEMIC RESEARCH AND WRITINGS; TO POST WRITTEN AND VISUAL MATERIAL ON THE WEB FOR EDUCATIONAL PURPOSES; TO CREATE MAPS AND COMPILE UNITS OF CURRICULUM FOR SCHOOLS AND INDEPENDENT LEARNERS, AND B) TO ENGAGE IN OUTREACH ACTIVITIES AND EDUCATIONAL PROJECTS WHICH HIGHLIGHT THE PEACEFUL EXCHANGES BETWEEN CIVILIZATIONS OF THE PAST; TO HOLD EXHIBITIONS, CONFERENCES AND SEMINARS ON THESE TOPICS.

**Activities:** THE CHARITY ADVANCES THE EDUCATION OF CHILDREN AND ADULTS IN PRE-MODERN WORLD HISTORY AND THE CONTACT BETWEEN CIVILIZATIONS BY POSTING FINDINGS OF ACADEMIC RESEARCH AND OTHER WRITTEN AND VISUAL MATERIAL ON THE WEB, CREATING A WEB-BASED HISTORY LEARNING RESOURCE, COMPILING UNITS OF CURRICULUM FOR SCHOOLS, AND ORGANISING EXHIBITIONS AND OTHER OUTREACH ACTIVITIES, CONFERENCES AND SEMINARS
