TO RELIEVE POVERTY AND NEED AMONG THE BENEFICIARIES BY PROVIDING SUPPORT IN THE FORM OF BURSARIES, GRANTS AND ITEMS TO THE BENEFICIARIES AND THEIR PARENTS, CARERS OR SCHOOLS, TO BE USED FOR SUCH PURPOSES THESE OBJECTS SHALL BE UNDERTAKEN IN UGANDA, THE UNITED KINGDOM AND ELSEWHERE AS THE TRUSTEES DETERMINE, PAYING ATTENTION TO THE PARTICULAR CHARITABLE NEEDS OF AFRICAN YOUNGSTERS OR THOSE OF AFRICAN DISSENT
