TO RELIEVE THE AGED, PARTICULARLY BUT NOT EXCLUSIVELY THOSE FROM THE TATAR COMMUNITY.5. TO PROTECT AND PRESERVE PUBLIC HEALTH BY THE PROVISION OF ADVICE, AWARENESS, ADVOCACY AND THE PROMOTION OF RECREATIONAL AND LEISURE TIME OCCUPATION
