TO HELP YOUNG LESBIAN, GAY, BISEXUAL AND TRANSGENDER PEOPLE, ESPECIALLY BUT NOT EXCLUSIVELY THROUGH LEISURE TIME ACTIVITIES, SO AS TO DEVELOP THEIR CAPABILITIES THAT THEY MAY GROW TO FULL MATURITY AS INDIVIDUALS AND MEMBERS OF SOCIETY. PROMOTE GOOD MENTAL AND PHYSICAL HEALTH FOR LGBT PEOPLE SUCH OTHER OBJECTS AS ARE CHARITABLE UNDER THE LAWS OF ENGLAND AND WALES AS THE TRUSTEES SHALL IN THEIR ABSOLUTE DISCRETION DETERMINE.

**Activities:** Tel, email & face to face support to LGB&T people, their family & friends; Information website; Training services & case-by-case interventions to other organisations; Schools & college sessions to students to address homophobia/transphobia & acceptance of LGBTQ people; Saturday daytime group in Gloucester for 14-18yr olds, 'GayGlos Youth'; Parents Group; Cross-sector strategic engagement.
